The Italian economy is powered by its industrial north and agricultural south, with the former contributing more as Italy significantly relies on manufacturing and services for economic growth. Based on the country's GDP of 1.65T Euros in 2020, services accounted for 66.69%, manufacturing for 21.62%, and agriculture for 1.99%. Its major industries include tourism, machinery, and pharmaceuticals, whereas its top exports consist of packaged medicaments, cars, and refined petroleum. As for its imports, crude petroleum, packaged medicaments, and petroleum gas are among the top products in 2020. In the same year, it was the 8th largest economy in the world by GDP, 7th in exports, and 10th in imports. Italy, however, has consistently been reporting stagnant economic growth due to their high public debt which was exacerbated by the COVID-19 pandemic. Its economy bounced back in 2021 when it reported a positive GDP growth of 6.5%.

Geographical Location: Italy is located in southern Europe. Several bodies of water can be found around Italy such as the Adriatic Sea on the east coast, the Tyrrhenian Sea on the west coast, and the Ionian Sea on the south. The countries of France, Switzerland, Austria, and Slovenia can be found in the north.

Climate: Mediterranean climate characterized by hot, dry summers and cold, rainy winters, has a variety of sub- and microclimates where seasonal weather can differ greatly from each part of the country. Global climate change is also known to affect Italy's weather, which is seen through more extreme weather events and warmer temperatures year-round.

Government Type: Parliamentary Republic

Standard of Living: Italy has a human development index of 0.892 as of the year 2020. It is ranked 29 out of 189 countries and territories.

TOP 3 TOURISM DESTINATIONS



ROME

Located in Italy's central region of Lazio, Rome is a historic city that has been a center for culture, power, and religion which is greatly seen through the Vatican City. Divided into several districts, it is the home of ancient attractions like the Colosseum, the Forum of Augustus, Capitoline Hill, and the Roman Forum, while the famous Pantheon can be found on the outskirts of the city. Tourists can also visit the Vatican City and explore St. Peter's Basilica, Apostolic Palace, and the Sistine Chapel.



FLORENCE

Known as the colossal outdoor museum, Florence is a treat for tourists as it is called internationally the birthplace of the Italian Renaissance. Florence became the inspiration for many writers, artists, inventors, and scientists as well as it is also the origin of opera and the florin currency.

The Cathedral of Santa Maria del Fiore is a landmark of world architecture that is recognized for its gravity-defying dome. Famous art galleries such as the Ufizzi and the Pitti Palace can also be explored by tourists.



INTERESTING FACTS

- Pizza was invented by Italians that resided in Naples in 1860.
- Italy, more than any other country, has 55 UNESCO world heritage sites as of 2019, including the City of Verona, the Amalfi Coast, and the Dolomites, which is why Italy is the 5th country in the world that attracts the most number of tourists.
- Italy has another country within its premises with the Vatican City, the world's smallest country, being in Rome, Italy.
- Italy is among the largest wine-producing countries alongside France and Spain due to their climate and abundance of vineyards. Italy even has a free-flowing wine fountain in Caldari di Ortona.
- The popular Trevi fountain literally means "three-ways" due to the intersection of three streets where it is located. Tourists also generate the fountain approximately 3,000 Euros on a daily basis, which are collected and given to charity.
- Aside from pizza and wine, Italy is also rich in cheese, having a variety of over 2,500 different types such as mozzarella, provolone, and parmesan.
- The Italian economy is the 3rd largest among the European Union members, the world's 13th largest based on GDP.
- Rome is also referred to as the Eternal City since ancient Romans believed that it would endure through time. In addition, having been founded in 753 BC, Rome is older than Italy itself.



VENICE

This top tourist destination in northeastern Italy is known for its beautiful bridges and canals as Venice is a city that is made up of 118 islands and built upon a lagoon. This destination is popular for tourists since they can take a romantic gondola boat ride in the middle of the Grand Canal. Beautiful landmarks such as Saint Mark's Square and Basilica and Doge's Palace are both overlooking the tall campanile. Cars are not frequently used in this city so people either walk or take water taxis to tour around.

Since first arriving in the Philippines to take up your post be completely eliminated. Only when we do not have as Italian ambassador how have you observed the relations between and the Philippines develop and progress?

The bilateral relationships have always been excellent in all contexts and can count also on the presence of a wellintegrated and hardworking Filipino community in Italy. 2022 marks the 75th anniversary of the establishment of the diplomatic relationship between the two countries and I hope that it is possible to organize an event to celebrate this important milestone. Now that the restrictions connected to the pandemic are likely to be steadily lifted it is realistic to foresee a further strengthening of the relations, in particular in the economic and trade sector. Trade and Industry Undersecretary Ceferino Rodolfo attended in June the prestigious Food and Beverage Bormio Forum during which he had the possibility to promote the many opportunities of import-export between Italy and the Philippines in this important sector. After the European summer break a new round of the bilateral political consultation between the MFAs will be held. It will be the occasion to set new goals to make the bilateral cooperation in all fields even more profound and profitable.



Filipino people are justly famous for their professionalism and dedication.

What do you find is the Philippines' greatest strength that would serve it best when doing business with Europe? What about the ASEAN neighbors?

Certainly, the human factor. Filipino people are justly famous for their professionalism and dedication. On top of that, the widespread knowledge of the English language and the Latin legacy in your culture and way of life represent an added value for anyone who wants to do business in the Philippines.

What do Italian businesses find most attractive about doing business with the Philippines?

As I said before, probably the Latin flavour which is disseminated in your culture, and which makes the Philippines most probably the easiest Asian country to live and work in for an Italian.

What do you envision as the future of business and trade between Italy and the Philippines? How do you think both partners can work better together to achieve this vision?

Before answering this question, I would rather wait for the pandemic to subdue and for the restrictions to restrictions of any kind anymore will it be possible to envisage that "vision".

What measures did Italy take in order to cope with the covid-19 pandemic? How do you build business resiliency?

Italy was unfortunately the first European Country (and the second all over the world after China) to have been hit by the pandemic. After the first phase of severe lockdown, the successful vaccination campaign and the wisdom of the Italian people allowed my country to cope with Covid-19 without irreparably damaging the economy and the social fabric. With all the necessary caution, Italy managed to get out of the darkest hour giving the world a model which was imitated by most Countries. In particular, it is to be stressed that schools and universities in Italy have been closed only in the first and worst period of the pandemic but that the academic year 2021-2022 has been practically normal for all students, albeit under the usual limitations (mask wearing and social distancing).

How did the pandemic affect trade relations between Italy and the Philippines?

The initial phase of the pandemic hit hard trade flows all around the world, so naturally also the bilateral trade between Italy and the Philippine, which decreased 23% during 2020. However, adaptation measures worked well and in 2021 we've seen a rebound of +18,9%, that has accelerated in the first three months of this year to a remarkable +35,2%. This proves the potential of growth arising from the complementarity of our economies.

What was the biggest hurdle of the embassy during the pandemic, and how was it addressed?

The biggest issues during the height of the pandemic were, of course, related to consular affairs: repatriation of our nationals stranded in the Philippines, taking care of our residents in the Philippines affected by COVID, helping reunite binational couples divided by the pandemic. Some of this intense consular work also regarded the trade sector: we worked with the Philippine Government to repatriate Philippine seafarers from Italy, and enabled crew changes of many ships gathered in the Manila Bay during the summer of 2020; we cooperated with the DFA, the Bureau of Immigration and various economic Departments to allow Italian businessmen, engineers and managers to return to the Philippines and resume their work on crucial infrastructure projects in the archipelago.

What was the biggest insight the embassy took from the

First of all, the pandemic was definitely a wake-up call on the need to modernize our work procedures and related IT infrastructure, in order to allow the continuation of our operations even during lockdowns, when most of our employees were in smart-working mode. It also brought a renewed attention to the health and wellbeing of our staff and the people - Italians and Filipinos - which use our consular and visa services, with the creation of new sanitary protocols that helped us avoid almost completely the shutdown of our activities.



Now more than ever, mental health is becoming a top priority in society. As an organization that cares for people's holistic well-being, Holcim Philippines, Inc. has recently organized back-to back mental wellness programs and activities for its employees and for a cause.

In the first leg of the company's employee mental wellness campaign, Holcim Philippines conducted an internal webinar dubbed "Self-Care. Self-Love. Be Kind to Your Mind" last October led by licensed psychologist and Certified Mindfulness Coach Rose Pattugalan, who talked about self-love practices that would help in managing stress and anxiety.

Pattugalan was joined by international award-winning interior designer and founder of CMM Interior Design and Consultancy Cara Marcelo, who talked about achieving mental balance and clarity through interior design.

Bases Conversion and Development Authority

A series of glorious peaks rises in the vista as and seamless travel. Unlike in the past, passengers travelers approach the horizon of Pampanga, one of the country's most historic Luzon provinces. The like gods of legends that have stood as guardians of the area and its people. These mountains, as well as other natural features and the cultural heritage of the region, provide ingenious references in the interior design of the new terminal building of Clark International Airport (CRK).

Bundled with the ease and comfort that will be accorded to travelers in the new terminal, the design artistry will all come together to make the total experience at the new CRK both pleasurable and meaningful. It will cement that sense of place, every time a passenger passes through.

International Airport, managed and operated by private consortium Luzon International Premiere Airport Development Corp. (LIPAD), is a four-level terminal with a total area of 110,000 square meters in the region. and has the capacity to accommodate eight million passengers annually. The new facility will serve both domestic and international flights.

When it opens, passengers can expect to experience unique features that make this terminal truly world-

First are contactless options. There will be selfservice kiosks for passenger check in as well as self-bag drops to ensure minimal contact between serving as Northern and Central Luzon's gatewaypassenger and airport personnel.

Another first will be the contactless ordering system for the terminal lounges and restaurants. Ordering food can be done via QR codes as guests sit themselves safely distanced while waiting for their food and beverage.

The new terminal is also intuitive and inclusive. Toilet categories have been expanded with Family Rooms, gender-neutral and PWD-friendly restrooms, while all boarding gates will have escalators and elevators, providing seamless access for all passengers.

A transit lounge has been dedicated exclusively for the use of overseas Filipino workers (OFWs), the country's modern-day heroes.

Another unique feature is the transfer desk which international passengers can use for convenience

from Kansai had to pick up their luggage, pass through immigration and re-check-in again for their peaks of Mt. Arayat and the Zambales mountains are Singapore flight. This time around, passengers can use the transfer desk upon arrival and go straight up to the departure area to wait for their next flight.


> The CRK new terminal also highlights the importance of technology to improve passenger safety as well as the on-time performance of aircrafts. The terminal will be using state-of-the-art "intelligent" Advanced Visual Docking Guidance System-a system which allows pilots to park aircrafts precisely and safely even in adverse weather conditions, using advanced laser technology.

The opening of Clark International Airport's new terminal building shall pave the way for CRK to achieve The new passenger terminal building of Clark its objective of becoming a premiere gateway in the Philippines—solving congestion in the metro, serving world-class comfort and convenience to millions of travelers, and accelerating economic developments

> Clark International Airport is expected to create 150,000 new jobs, equating to 0.4% of the total employed population in the Philippines. The tourism, food and beverage, services, infrastructure, agriculture and manufacturing industries are expected to benefit when Clark airport becomes fully operational.

Food and Drug Administration Philippines Gives Emergency Use Authorization (EUA) for Pfizer's Novel COVID-19 Oral Treatment in Philippines

Pfizer

MANILA, PHILIPINES, 17 March 2022 – Pfizer announced today that the FDA Philippines has granted the Emergency Use Authorization (EUA) for the supply and use of Nirmatrelvir 150 mg / Ritonavir 100 mg (PAXLOVID) Film-Coated Tablets in Philippines. PAXLOVID is indicated for the treatment of COVID-19 in adults who do not require supplemental oxygen and who are at increased risk for progression to severe COVID-19.

PAXLOVID is the first oral treatment of its kind; it includes nirmatrelvir, a 3CL protease (also known as Main protease or Mpro) inhibitor that was specifically developed in Pfizer's laboratories to combat SARS-CoV-2. This oral treatment and should be taken within the first five days of symptomatic infection.

"This milestone in Philippines is an important moment in our continued fight against COVID-19, paving the way for use of PAXLOVID as we address the threat of a new variant of concern, Omicron. We are honored to have been working with the FDA Philippines and want to commend them for their fast-track assessment of PAXLOVID to grant the Emergency Use Authorization" said Edilberto Reyes, Pfizer Philippines Interim Country Manager.

"Whilst vaccination remains to be an effective way to help prevent COVID-19, this oral treatment provides us with another important line of defense - to reduce

hospitalizations and help save lives. PAXLOVID has the potential to transform COVID-19 treatment and help lessen the devastating impact of the virus globally." Mr. Edilberto Reyes said.

FDA Philippines based its decision on positive results from the Phase 2/3 EPIC-HR (Evaluation of Protease Inhibition for COVID-19 in High-Risk Patients) interim analysis, which enrolled non-hospitalised adults with confirmed COVID-19 who were at increased risk of progressing to severe illness. The data showed that PAXLOVID reduced the risk of hospitalization or death by 89% (within three days of symptom onset) and 88% (within five days of symptom onset) compared to placebo, with no deaths observed in the treatment group. Treatment-emergent adverse events were comparable between PAXLOVID (23%) and placebo (24%), most of which were mild in intensity. Treatment-emergent adverse events were comparable between PAXLOVID (23%) and placebo (24%), most of which were mild in intensity. These data were recently published in the New England Journal of Medicine. Additional Phase 2/3 clinical trials are ongoing in adults at standard risk (i.e., low risk of hospitalization or death) of progressing to severe illness, and in those who have been exposed to the virus through household contacts.





Ensuring Energy Security for Tomorrow 04 May 2022
























Mindanao Talks: Impact of the Current Crisis to the Energy Sector




The 5S + 2S Process (with Files and Record Management)


Reforestation and Sustainability: Realigning Strategies for Climate Change Mitigation



In addition, the representatives talked about the priority legislation of the JFC, including the creation of the Philippine Transportation Safety Board, Digital Payments, and the implementation of the Extended Producers' Responsibility (EPR) scheme. Updates on the Arangkada Forum and the New Congressional leadership were also discussed during the face-to-face meeting.

12 May 2022



17 June 2022


