Geographical Location: Austria is located in the southern part of Central Europe. It is bordered by Switzerland, Liechtenstein, Germany, the Czech Republic, Slovenia, and Italy.

Climate: Austria has temperate and an alpine climate. It has all 4 major seasons although it varies throughout the country.

#### Official Language: German

Government Type: Austria is a federal parliamentary republic. The head of the government is the Chancellor and the head of the state is the President. The Austrian Parliament consists of two chambers: the National Assembly (Nationalrat) and the Federal Council (Bundesrat). It also has nine (9) independent federal states; Burgenland, Carinthia, Lower / 'etria, Salzburg, Styria, Tyrol, Upper Austria, Vienna, and Vorarlberg.

Standard of Living: The average household net-adjusted disposable income per capita is USD 37,001 a year which is considered above the OECD average of USD 30, 490 a year. The Human development index (HDI) of Austria is reaching 0.916 in 2021 which indicates a very high level of development by the UN definition.

### FINANCIAL DISTRICT

A wide range of institutions handles financial services, including large nationally owned and foreign banks, the Austrian Post Savings Bank (Österreichische Postsparkasse), smaller local savings banks, and commercial credit and agricultural credit cooperatives. Founded in 1771 by Empress Maria Theresa, the Vienna Stock Exchange (Wiener Börse) is one of the oldest institutions in Europe where shares of both Austrian and foreign companies are traded there.

Austrian private investors and entrepreneurs have found a new arena for foreign investment in Austria's former imperial domains such as Hungary, Czech Republic, Slovakia, Slovenia, Croatia and, to a lesser extent, northern Italy. Since the mid-1990s, thousands of Austrian companies that are mostly small and medium sized have been involved in investment projects in these countries. An extensive network of OMV gas stations and numerous branch offices of Bank of Austria are some notable examples of Austrian ventures in eastern European countries.

### **INTERESTING FACTS**

- Austria is a landlocked country in East Central Europe. The country is only surrounded by land, mountains and forests. 62% of the country is covered with mountains. Austria is covered by mountains, most of them are called Alps, but there are others especially in the East.
- Austria is comparatively high in elevation in contrast to other countries. It has an average elevation of 910 meters above sea level and about 30% of the country is found anywhere below 1,640 feet. The highest peak or mountain is at approximately 12,461 above sea level.
- More than half of electricity in Austria comes from hydropower. Due to its alpine topography and abundant rivers, the country was able to utilize hydropower as their main source of electricity production. The Alpine country also boasts one of the largest pumped hydropower storage capacities in the region.
- The Austrian flag is one of the oldest flags in use in the world dating from 1230. Although, the red and white triband is said to be used as early as 1105
- Austria's Gross Domestic Product per capita is at \$53, 637 in 2021 which makes it one of the fourteen richest in the world in terms of GDP per capita. The country's economy focuses on foreign trade.


### SCHÖNBRUNN PALACE

Schonbrunn Palace is a UNESCO World Heritage Site. It is one of Europe's most beautiful Baroque palaces which is a former summer residence of the Habsburg in Vienna. It consists of 1,440 rococo style rooms with massive sculpted garden space and lavish architecture designed by the architects Johann Bernhard Fischer von Erlach and Nicolaus Pacassi. It has been one of Vienna's major tourist attractions with over millions of people from all over the world visiting each year.



### HALLSTATT-DACHSTEIN



Since first arriving in the Philippines to take up your post as Austrian Ambassador, how have you observed the relations between Austria and the Philippines develop and progress?

I arrived at the end of August last year, the very day children started to go back to school. Everything gradually opened up and you could sense the positive mood that came with the regained freedoms. The current administration actively looks outside and travels, sending the right messages and inviting people and businesses to take a fresh look at opportunities in the Philippines. We can feel that every day and the numbers support that with our bilateral trade set to surpass the all-time-high of 2017.

What do you find is the Philippines' greatest strength that would serve it best when doing business with Europe? What about with its ASEAN neighbors?

The Philippines has a rich pool of well-educated young people whose English proficiency is a real asset for doing business with Europe. The previous government has already put in place measures that improve the ease of doing business. Continued pressure in cutting red tape while setting further structural measures by the current administration to create an enabling environment will continue to increase the attractiveness of the Philippines as an investment destination.

# What do Austrian businesses find most attractive about doing business with the Philippines?

Global competition is fierce and a business friendly and highly efficient environment in terms of power supply, connectivity and digital infrastructure are necessary preconditions. The government is addressing these issues and highly innovative Austrian companies have already proven in the past the contribution they can make in supporting the infrastructure development of the Philippines. The Philippine government's "Build, Better, More" seems to attract even more Austrian companies to establish subsidiary or even regional headquarters in the Philippines.

What do you envision as the future of business and trade between Austria and the Philippines? How do you think both partners can work better together to achieve this vision?

To be successful in distant markets, personal contacts and the right partners are of utmost importance. The post-Covid recovery and the growth dynamics of the Philippines send the right messages and I am pleased to report that we are currently in preparations for the visit of a strong business delegation from Austria to the Philippines in April to see for themselves.

Austrian companies see potential with infrastructure, water and wastewater management, renewable energy and sustainability, circular economy as well as health and agriculture in the Philippines.

Are there Austrian outlooks on health and nutrition that can inspire our partners to live a healthier lifestyle you would like to share?

Austria is located at the heart of Europe, in a magnificent landscape. The Alps provide the romantic backdrop for a small, exquisite world, wholly dedicated to taking pleasure in natural products. Juicy green meadows, blossoming fields and untouched alpine pastures grow the ingredients. These are then transformed into a range of specialty products by both the traditional, small-scale Austrian agricultural industry and the processing institutions, inspiring palates around the whole world. I think one of the similarities between Austrian and Filipino culture is our love for food.

In public polls, Austrian consumers usually express a preference for high quality, regionally, and sustainably produced foods. We believe that dietary behavior influences health as well as the development and course of certain diseases and works hand in hand with physical activity that makes an essential contribution to maintaining health and well-being.

Austria is the first country to establish national regulations regarding organic farming. Regulations were already introduced in 1983 and served as the basis for the control of organic farming by the authorities until Austria's accession to the EU. Organic farming is a way of agricultural production which uses organic production methods and places the highest emphasis on environmental and wildlife protection and with regard to livestock production, on animal welfare considerations. Organic food production is playing a continuously increasing role all over the world and Austria is a pioneer in this field!

In fact, the highest share of organic farming areas in the EU is recorded in Austria. In 2020, the total area of Austrian agricultural land under organic farming is 25%. And in the Salzburg region of Austria, about one half (52%) of the total utilized agricultural area is used for organic farming in 2016, the highest share among EU's regions.

# What were the major nutrition and health-related challenges faced by Austria, and how were these addressed?

Austrians have been paying more attention to their diet since the beginning of the COVID-19 pandemic but unhealthy lifestyles remain a key public health challenge. Although there are challenges in implementing policies to discourage and reduce alcohol consumption and smoking, long planned reforms have come into place. For example, the 2014 Health Promotion Strategy put greater emphasis on prevention and health promotion, including the creation of health promotion funds in each state - supported by € 15 million per year until 2022 - that aim to strengthen health promotion and prevention. At least two-thirds of the funding must be spent on prevention targeting certain groups or activities, including early childhood (healthy nurseries, kindergartens and schools), strengthening health literacy and promoting the well-being of older people (BMASGK, 2019).

The World Health Organization recommends at least 150 minutes of moderate-intensity physical activity per week for the population aged 18-64 as well as muscle-strengthening activities on at least two days per week. Austria has a lot of national policies or action plans for the promotion of physical activity for health involving various sectors (health, education, sports, environment, urban planning, transport) to coordinate the working group on health targets to promote healthy, safe exercise and activity in everyday life through appropriate environments.

One of the many good examples is the national funding programme "klimaaktiv mobil" in the Ministry of Climate Action that has provided financial support for companies, federal states and municipalities to promote cycling, including infrastructure since 2007 and in 2020, the national budget was doubled to € 40 million per year. Additionally, new funding was provided for bicycle lanes which brings us to The Masterplan cycling 2015-2025 strategy. This aims to increase the prevalence of cycling from 7% to 13% as a health-promoting measure, reduce health and environmental costs and increase training in cycling, raise awareness and invest in promotion of cycling throughout the country, with development of infrastructure, cycle-friendly legal conditions and a pan-European Master Plan for Cycling Promotion in the context of the UNEC/WHO Transport, Health and the Environment Pan-European Programme.

# Are there notable public-private partnerships on health and nutrition?

Styria vitalis is an independent non-profit organization that provides tools, expertise and methods concerning health promotion and prevention throughout the province of Styria. They address topics such as healthy eating and drinking, dental health, exercise, mental health and the promotion of community and social cohesion. They also create healthy living conditions by providing healthy

school buffets, barrier-free paths, attractive playgrounds, and meeting places of which the municipality of Lieboch (Graz, Austria) successfully implemented several projects through this partnership and provided health courses, lectures and health day to inform its citizens regularly about health topics.

Similarly, the municipality of Mistelbach in Lower Austria started a similar program which started in 1995 with the aim of making the participating communities health-promoting and taking preventive measures that are oriented towards Austria's health goals. The municipality works closely with representatives of various organizations and stakeholders and provides lecture programs, which deals with the topics of exercise, nutrition, nature and the environment, mental health and medicine/prevention. The municipality, through the "healthy community" also established a hiking trail and provided herbal apprentice courses, healthy cooking courses, and supported school projects through workshops, movement and swimming courses, etc.

And as you can tell, Austria places a high priority on health. I would say that one of the notable public-private partnerships on health and nutrition are the works of the Austrian Health Promotion Fund (FGÖ)—a business unit of the Austrian National Public Health Institute which provides funding and a competence center for health promotion and prevention.


FGÖ's activities are focused on project funding. It financially supports health projects from all over Austria which are planned and implemented by committed organizations. FGÖ also disseminates knowledge, develops skills and competencies in the field of health promotion through training opportunities in partnership and close cooperation with stakeholders and actors. The FGÖ also promotes the exchange of practice, science and politics in the field of health promotion.

Another remarkable partnership is the establishment of Healthy Cities Network in 1992. It is the Association for the Promotion of Health Awareness in Austrian Cities. The Austrian network is part of the WHO National Healthy Cities Network and is tasked to coordinate and exchange information among Healthy Cities and provide advice and assistance in the implementation of Healthy Cities projects.

# Dr. Imelda Agdeppa



### What are the driving factors of persistent malnutrition or undernutrition in certain areas of the country?

The 2018-2019 ENNS reported that more than half (56.0%) of Filipino households were classified as food insecure.

The persistent malnutrition problem in the has immediate, underlying, and basic causes.

The major immediate causes arise from inadequate dietary intake and the presence of disease. These immediate causes are linked with underlying causes at the household, community, and societal levels which include food insecurity, poor caring and feeding practices, poor home environmental conditions, and inadequate health care services, in some cases, poor access to health care services, poor biodiversity, and poverty. Malnutrition deprives children of the opportunity for optimum growth and development.

### What are the programs and initiatives in place to help make nutrition more accessible for all Filipinos?

There are existing nutrition programs being implemented by the national government, local government units, nongovernment organizations, and private sectors. These programs include:

The implementation of robust programs and policies during 2. Use the results of the National Nutrition Survey as basis the First 1,000 Days. The Republic Act No. 11148 (Kalusugan at Nutrisyon ng Mag-Nanay Act), and Republic Act No. 11037 (Masustansiyang Pagkain para sa Batang Pilipino Act) supported the different nutrition programs to be more available and accessible to the people (i.e., deworming, vitamin A supplementation, ferrous sulfate, iron-folic acid, pre- and post-natal services, nutrition education, counseling, etc.).

Another program is the Operation Timbang Plus (OPT+). It is an annual weighing and height measurement activity done among 0-59 months old children in the community to identify and locate undernourished children. The OPT+ results are used as a basis in planning and implementing nutrition programs such as feeding interventions and the conduct of nutrition education among mothers and caregivers.

In the schools, nutrition assessment, school feeding programs, nutrition educational campaigns. As part of the anti-hunger mitigation program of the government, crops and livestock are distributed to targeted beneficiaries (poor households) in the community. To improve food security status of the households, the local government units through the Department of Agriculture encouraged households to establish their own vegetable garden, along with the distribution of seedlings. There is also Gulayan sa Paaralan program where the produce is utilized as ingredients for the school feeding program to make the food served more nutritious and encourage children to eat vegetables.

We at the Department of Science and Technology-Food and Nutrition Research Institute serve as the research arm of the government in giving up-to-date information on the country's food and nutrition situation and even on some health indicators where the DOST-FNRI is the official source of data. Developed nutritious products are used in supplementary feeding programs of the NNC, DepEd, and DSWD.



Adopt the technologies so that these will cover more people in need especially in the hard-toreach areas.

How can the private sector contribute and collaborate with your office in promoting Nutrition and wellness?

There are so many ways how the private sectors could collaborate in promoting nutrition and wellness:

- 1. Be our partner at the grassroots by advocating the use of the Pinggang Pinoy; disseminating the Nutritional Guidelines at the local government units.
- in crafting nutrition programs or interventions so these will be area-specific, more cost -effective and cost efficient.
- Adopt the technologies so that these will cover more people in need especially in the hard-to-reach areas.
- 4. Fund research that responds to the current needs for food, nutrition, and technological services.

### In your opinion, how huge is the influence of social media in today's time in terms of food, nutrition and eating habits of the Filipinos?

Due to the growing presence of social media in Filipinos' lives nowadays, especially with the introduction of TikTok, many food and beverage products are being marketed by different companies or brands or people. As such, Filipinos, specifically adolescents are influenced by this vast amount of information available with just a tap or click away. Take for example the coffee trend that started at the height of the pandemic in 2020 wherein many people around the world as well as Filipinos took part in this craze (Kang, 2020; Kirkwood, 2020). This shows that social media really does play a huge part in today's time in terms of food, nutrition, and eating habits of Filipinos. However, depending on the nutrition value of the products being marketed, social media advertisements' influence may contribute to the risk of developing unfavorable health outcomes such as obesity, hypertension, and type 2 diabetes (Kucharczuk et al., 2022).

Social media is an effective tool or platform that can be used to provide awareness and promote healthy lifestyle habits such as healthy eating, increased physical activity, avoid smoking and excessive drinking of alcoholic beverages. However, as social media users, we must be vigilant on the information being shared and the source of this information because we might be getting the wrong or incorrect information and that these may be shared to a lot of people causing a domino effect.

Are there any factors that would hinder the effectiveness of nutritional campaigns/feeding programs? What are the key performance indicators used to measure the success of a nutritional campaign?

#### A. Nutritional Campaign

Several factors might influence the effectiveness of nutritional campaigns and this can be at the individual, sociocultural, and local level. At the individual level, barriers in making healthy dietary choices include personal preference, age, gender, culture, education, income, health status, nutritional, as well as attitude toward food and health, motivation, and values.

The sociocultural factors include family and community norms, social pressures, social class, social networks, race, and ethnicity as well as the local environment where one thrives. Apart from these, wider commercial pressures also affect consumer choice, including food packaging, marketing, advertising, and sociocultural perceptions of norms, status, and prestige (Mozaffarian et al., 2018).

Monitoring and evaluation (M&E) should be in place to determine the effectiveness of a nutritional campaign. Evaluation could be in terms of the number or percentage of individuals who reported practicing a certain nutrition-related behavior, etc.

### B. Feeding Programs

A lot of factors might hinder the effectiveness of a feeding program.

This include lack of manpower or inadequate training of the implementers; lack of resources such as functional equipment in measuring weight and height to determine the nutritional status of children before and after the program; proper targeting of program beneficiaries; unsupportive parents of children beneficiaries; lack of monitoring and evaluation (M&E) component or there are gaps in M&E; and

nutrition programs not being the priority program of the LGU. Low support of the LCE may affect program sustainability in terms of budget and support for manpower, among others.

The presence of the M&E component of the program will determine whether it is effective or needs improvement in the implementation. Key performance indicators may include the number or percentage of children who gained weight after the intervention; prevalence of underweight or thin children at the end of the program; number or percentage of children with improved nutritional status (i.e., underweight to normal weight-for-age status); and number or percentage of children with illness before, during and at the end of the intervention.

How do you advocate for programs that help promote healthy lifestyles among your citizens? (Ex. encouraging citizens to walk or bike as part of their daily commutes, recommending nutrient efficient meals to company cafeterias)

Our mandate includes defining the nutritional status of Filipinos; developing tools, standards and nutritious products to address the identified nutrition problems as well as recommend policies and programs; and disseminating the research findings to relevant stakeholders. As DOST-FNRI is not an implementing agency, the Institute coordinates with different agencies and organizations in providing evidence in the implementation of nutrition programs. We also provide technical assistance in the adoption of our technologies to help alleviate malnutrition, like the Malnutrition Reduction Program (MRP), and the Enhanced Nutribun which now has many variants. We also lobby for policy recommendations to relevant stakeholders, both at the local and national levels, in order for them to prioritize and address pressing issues in nutrition like food security and undernutrition.

Ensuring proper dietary habits is crucial especially now that we are still in a pandemic. The use of different tools developed by the Institute may guide Filipinos to achieve a healthy lifestyle. These tools are posted in our social media accounts.

We have the Nutritional Guidelines for Filipinos (NGF) that contains all the key nutrition messages to healthy living for all age groups from infants to adults, pregnant and lactating women, and the elderly.

We also have the Pinggang Pinoy, a simple, visual tool to guide Filipinos in consuming the right amount of food in every meal. It is an easy-to-understand guide that uses a familiar food plate model to show the right food group proportions on a per-meal basis to meet the energy and nutrient-needs of an individual. The plate represents proportions of foods belonging to the Go, Grow and Glow food groups. Half of the plate is for Glow foods consisting of fruits and vegetables while one-sixth of the plate is for Grow foods like meats, eggs, poultry, fish, beans and legumes. Meanwhile, one-third of the plate is taken-up by the Go foods such as rice, corn, bread, oatmeal, and root crops.

# Food & Beverage Committee

As one of the Chamber's long-standing committees, the ECCP Food and Beverage Committee advocates for measures aimed at promoting ease of doing business in the food and beverage industry as well as resolving the issue of food insecurity and malnutrition in the country, among others.

Over the years, agri-food systems have played a central role in the discussion on sustainable development particularly due to the adverse impact of the COVID-19 pandemic and climate change that have exacerbated the challenges in achieving food security. Access to healthy diets also remains to be an issue as malnutrition continues to manifest in various forms, with an estimated 149 million children under the age of five being stunted and over 45 million suffering from wasting, as reported by the World Health Organisation. Today, the road to achieving the goal of ending hunger and malnutrition in all its forms remains to be challenging as global food prices continue to soar.

In this context and in line with the committee's advocacy to promote good health and wellness in the country, the Committee has conducted several initiatives to raise awareness on the significance of nutrition in the country's plight towards recovery including the following:

- Nutrition Profiling and Responsible Marketing to Children: Held last 22 November 2021, the online session featured government updates on nutrition profiling and regulation of the marketing of food to children, as well as valuable insights from regional and local industry players on solutions and strategies to resolve child obesity.
- Hybrid Advocacy Event on Nutrition and Wellness
   The ECCP, in partnership with its Food and
   Beverage Committee, organized a hybrid

advocacy program focused on Nutrition and Wellness for the community of Muntinlupa City. This event was created with the important goal of collaborating with stakeholders and consumers to plan a sustainable journey towards achieving a healthy society and covered The hybrid session covered the following topics:

- Basic nutrition (understanding basic nutrients and importance of a balanced diet)
- Understanding the label (front and back packaging)
- Physical activity & health, etc.

Building a Healthier Philippines: Strengthening Partnership and Policies for Nutrition

Held last 31 August 2022, the hybrid event featured discussions on the plans and programs of the new administration to resolve the issue of food insecurity as well as promote nutrition and multi-stakeholder dialogues on innovative solutions to improve nutrition outcomes.

In continuation of these dialogues, the Committee is scheduled to host a hybrid event in April 2023 with focus on promoting healthy diets and achieving food security against the backdrop of a high inflationary environment.

The ECCP, through its Food and Beverage Committee, is a steadfast partner of the government in pursuit of our shared advocacy of ending hunger and all forms of malnutrition in the country for a healthier and stronger Filipino population.

# Pru Life UK drives up financial inclusion through 'insurtech' policy paper

'Insurtech' essential in driving broader insurance access



Manila, Philippines (06 March 2023) Leading life insurer Pru Life UK released a policy paper called "InsurTech: Driving Broader Insurance Access," giving a better understanding of how insurtech such as online shopping platforms can be used to broaden Filipinos' access to life and health protection products.

Authored by leading law firm Romulo Mabanta Buenaventura Sayoc & de los Angeles, the policy paper reviews the current regulatory framework for electronic commerce of insurance products and looks at how online shopping platforms can serve as insurance intermediaries. "The full potential of online shopping platforms has up to now not yet been maximized, likely because online shopping platforms are not insurance-specific. As InsurTech evolves the way of doing the insurance business, insurers need to keep up," says Atty. Cynthia Del Castillo, Senior Partner and Head of the Capital Markets Practice at Romulo Mabanta Buenaventura Sayoc & de los Angeles.

"It is our purpose at Pru Life UK to help Filipinos get the most out of life. We are inspired to lead the discussions and concerted initiatives with many like-minded partners to leverage mobile and online apps and platforms to drive up financial/insurance awareness, literacy and inclusion to help many more Filipino families in the country," shares Pru Life UK

President and CEO Eng Teng Wong.

Key recommendation of the paper is for the Insurance Commission to consider allowing online shopping platforms, including electronic wallets that are serving as e-commerce platforms, to act as an "intermediary" for the sale and distribution of insurance products, including investment-linked insurance products, under a three-tiered classification of intermediaries as follows:

- Those that provide advice and client servicing such as insurance agents and brokers;
- Those that provide advice but not client servicing, but require a degree of knowledge of insurance products such as online insurance aggregators; and
- Those that merely provide a platform that connects the insurer and the consumer for online distribution of insurance products, and do not provide advice and / or client servicing such as online shopping platforms, online marketplaces and e-wallets.

"Digitalization has accelerated almost every aspect of our lives. However, the insurance penetration in the Philippines as a percentage of the national Gross Domestic Product (GDP) is less than 2 percent. This is amongst the lowest in Asia. By harnessing the combined strengths of financial advisor workforce and the power of mobile and online apps and platforms, we can quickly broaden the reach and accessibility to many more affordable life and health insurance solutions, including investment-linked plans," shares Wong.

Wong is also FinTech Alliance Philippines' Insurtech Committee Chairman leading the organization's role in engaging, building, and expanding a sustainable digital finance ecosystem.





# Inside ECCP: Iloilo

Water is Too Big 27 February 2023



Realizing that the Philippines, along with other United Nations (UN) member states, is a signatory to the 2030 Agenda for Sustainable Development, the ECCP - as a staunch partner of the European-Philippine business community – undertook the initiative of being involved in sustainability-related advocacies, bolstering alliances with the Philippine government as well as reinforcing ties with stakeholders. Accepting the sustainable development goals (SDGs) framework as the country's roadmap for sustainable development, ECCP Visayas Chapters conducted its first-ever hybrid forum last February 27, 2023 entitled, "Water is Too Big: A Dialogue on the State of the Water Sector in the Visayas." This event was held at SEDA Hotel Atria with the presence of a diverse panel of experts as they imparted impeccable knowledge and insights on the ways to address the region's water challenges, as well as the measures in achieving the goal of clean water and sanitation for everyone.

The event was commenced by welcoming remarks delivered by ECCP Western Visayas Business Council Chairman, Mr. Joe Bantiling. In view of the hybrid setup, NEDA VI OIC Regional Director Engr. Arecio Casing Jr., Metro Pacific Water President Rogelio Singson, and ARUP Water Lead Adrian Marsden were able to deliver their presentations onsite, whereas Philippine Institute for Development Studies Senior Research Fellow Dr. Roehlano Briones and Public-Private Partnership Director Maria Lerma Advincula were able to impart their knowledge via online.

The event was well attended by more than 40 onsite participants which was both an exciting and engaging experience to learn more about the water sector in the visayas. It is made possible by the event supporter lloilo Provincial Government, and partners Metro Pacific lloilo Water, ARUP, Clewat, and Waste Trade.

Once the presentation of each speaker has been concluded, the panel discussion took place with stimulating questions left and right from the audience, eagerly answered by both virtual and onsite panelists.

Moreover, the forum was moderated by Dr. Joan Alice Ferrer, a professor and a scientist from the University of the Philippines Visayas.

The panelists highlighted several key challenges facing the water sector in the Visayas. These included the lack of access to safe and clean water for some communities, especially in rural areas. The panelists noted that while progress has been made in increasing access to water supply, the quality and reliability of water services remain a major concern.

Additionally, the panelists discussed the impact of climate change on the water sector, such as extreme weather events and sea-level rise, which exacerbate water scarcity and pollution. They also emphasized the importance of governance and institutional arrangements in ensuring sustainable and efficient water management.

# Public Consultation on the IOG of PPA Administrative Order No. 04-2021 4 January 2023

Last 4 January 2023, ECCP Associate Director Sophia Ordoña attended the Public Consultation on Philippine Ports Authority (PPA) Administrative Order (AO) No. 04-2021 at the PPA Corporate Bldg. Bonifacio Drive, Port Area, Manila. The said AO, entitled "Policy on the Registration and Monitoring of Containers," took effect on 19 October 2021. Section 6 thereof states that the PPA shall prescribe the Implementing Operational Guidelines (IOG) on the Trusted Operator Program-Container Registry and Monitoring System (TOP-CRMS) and that prior consultation with affected sectors shall be conducted before its implementation.
