SWITZERLAND TRADE AND INDUSTRY

Switzerland and the EU have negotiated bilateral economic agreements to promote commerce. The 1972 Free Trade Agreement (FTA) opened the door for the gradual growth of a closer relationship with the internal market. In order to make it easier for both parties to access markets and reduce trade barriers, Switzerland and the EU signed the Bilateral Agreements I in 1999 after the Swiss people turned down the opportunity to join the European Economic Area (EEA) in 1992. Five of the seven agreements are related to market access. Nine agreements, including one on commerce, comprise the Bilateral Agreements II, which were signed in 2004. These agreements support close collaboration in a variety of different areas and largely ensure that market access is reciprocal. They also prevent discrimination against Swiss businesses operating in the EU's internal market (research, safety, asylum, environment, and culture).

Switzerland may experience a direct impact from EU economic policies. They have an impact on the political and economic ties between Switzerland and the EU. Swiss exports are directly impacted by EU rules. The developments taking place in the EU are constantly monitored in Switzerland, and its economic operators are examined for any implications.

Geographical Location: Switzerland is located in the heart of Europe. The country is bordered by five (5) countries: Italy, France, Germany, Austria, and the Principality of Liechtenstein.

Climate: Switzerland has a temperate climate with four distinct seasons. Its climate is greatly influenced by the Alps and its proximity to the Atlantic Ocean.

Official Language: German, French, Italian, Romansh

Government Type: Switzerland is a federal state. The states power is divided between the Confederation, the cantons and the communes Standard of Living: witzerland's Human Development Index (HDI) for 2021 is 0.962, ranked as the top country out of 191 countries. Organizations:

There are numerous local cantonal and regional banks, asset managers, and family offices in addition to major and private banks with an international focus. ZERMATT

Jungfraujoch is the tallest mountain in Europe. It is often referred to as the "Top of Europe" for its observation deck which is 3,454 meters high. The Swiss Alps Jungfrau-Aletsch, a UNESCO World Heritage Site, is home to Europe's highest railway station, where the Jungfrau railway has been operating for more than a century. The cog train from Kleine Scheidegg ascends steeply through a tunnel to the Jungfraujoch all throughout the year. The seven-kilometer tunnel that rises from the station Eigergletscher was constructed between 1896 and 1912. Through windows in the Eiger North Face, one stop in the tunnel offers breathtaking views of the glacial world outside. Visitors are met at the peak by a high-Alpine wonderland consisting of ice, snow, and rocks. From the "Ice Palace" or the "Sphinx" viewing platforms on the Aletsch glacier, one can take in all of this.

Zermatt is one of the most alluring vacation communities in the world due to its location at the foot of the Matterhorn and in the center of a sizable hiking and skiing area. The ski area has 360 kilometers of slopes and 54 mountain railways and lifts. The largest and highest-lying summer skiing area in Europe is the area known as "Matterhorn glacier paradise." In the summer, a lot of national ski teams train here. The Haute Path, a difficult international route that takes many days to complete, runs from Mont Blanc to Zermatt, and the area is famed among mountaineers. The Matter Valley is traversed by more than 400 kilometers of hiking paths, including the 13th-century mule traders' trails (a section of these trails is still in use today).

INTERESTING FACTS

- Switzerland is a small country made up of glaciercarved Alps, lakes and valleys. However small, Switzerland consists of 7000 lakes and it's the best ones to swim in. The lakes are mostly made up of freshwater so clear that it is safe to drink. Alongside the lakes, Switzerland also has 208 mountains and the highest peaks in Europe.
- Switzerland has been directly associated with the Alps ever since even with only less than 15% of the Alps lie within the country.
- Switzerland is known to be one of the most expensive places to live in. This is complemented by economic stability. Switzerland surpassed the United States of America for having the highest salary. Therefore, having low unemployment rates and low rates of people in poverty.
- Switzerland has ranked #1 as the most innovative country in the world for the past 12 years.
- Switzerland is prepared for a nuclear threat. According to Article 45 and 46 of the Swiss Federal Law on Civil Protection, "every inhabitant must have a protected place that can be reached quickly from his place of residence" and "apartment block owners are required to construct and fit out shelters in all new dwellings." Therefore, ensuring the entire population can be accommodated when the need arises.



BASEL

Basel is the oldest university city in Switzerland. The city's late Romanesque-Gothic cathedral and the expansive market square with its ornately adorned red sandstone town hall are among its historic features. A stop at the "Läckerli Huus" to sample the typical Basel honey cake is well worthwhile while strolling through the old town past modest boutiques, antique book shops, as well as shops of new designers. Basel is both open-minded and tradition-conscious, as evidenced by the numerous contemporary structures constructed by eminent architects like Herzog & de Meuron, Mario Botta, Diener & Diener, and Richard Meyer. It has the highest concentration of museums in the nation. Numerous galleries and playhouses, as well as internationally renowned museums like the Basel Art Museum, the museum honoring the iron sculpture Jean Tinguely, the Fondation Beyeler, and the Museum of Cultures, draw sizable crowds of visitors.

What do Swiss businesses find most attractive about doing business with the Philippines? What are their main considerations in entering the Philippine market?

Have there been efforts to expand Swiss companies across the Philippines? What are the steps taken by the government? What are the challenges faced by companies?

What do you envision as the future of business and trade between the Swiss Confederation and the Philippines? How do you think both partners can work better together to achieve this vision?

I think a more tech-enabled Philippines fast-tracks inclusive change because it cuts the processing time of business transactions, promotes transparency which in turn lessens corruption, and easily measures impacts to economy, environment, and people including the protection of human rights for a more stable, progressive, and sustainable development. A large part of Switzerland's economic growth is fueled by private-sector innovations and discoveries because the environment encourages healthy competition amongst industries, rewards pioneering solutions, and puts a very high premium on human capital development. We have been partners with the Philippines along these areas, and I think we just need to sustain the momentum, be more proactive in pushing for economic reforms, and continuously identify points for collaboration to enhance our bilateral relations. Finding and working on mutual opportunities require a reiterative process, hence, it is always a work in progress.

Switzerland is ranked as the most innovative country in the world. How does Switzerland keep up with technological advancements?

Switzerland has indeed ranked as the most innovative country in the world in the last 12 years. Switzerland has always been quick to utilize new technologies to create robust innovation across a range of industries, from the financial services to healthcare and life sciences. There are different factors to explain this top ranking. First Switzerland can be seen as a nation of inventors with of the highest patent application ratio in Europe. Second, Switzerland has world-class research institutes with universities ranking among the best worldwide. Third, the investments by multinationals based in Switzerland allow research and development and provide a valuable link between work done in universities and the industry. Switzerland invests over CHF 23 billion in R&D annually, which makes it one of the largest R&D investors in the world. Two-thirds of all R&D is funded by the private sector.

There are numerous emerging technologies in Switzerland. How do they decide which technologies to prioritize and how do they find funding?

The pace at which new technologies arise is impressive and also raises a series of questions. What is their purpose and how can their potential be realized? What about the ethical and legal considerations? As a country Switzerland wants to create the best possible framework conditions and evolve as a leading, innovative and sustainable location for new technologies while at the same time combat abuses and ensure integrity. For the companies it is important to maintain a clear view over solutions that may impact your industry. Investing in the most relevant technologies can create significant competitive advantage. By contrast, failing to do so can hinder sustainable and profitable growth, as well as enabling competitors and new market entrants to steal the lead. The company is obliged to think ahead and not take the status quo for granted.

Artificial Intelligence is an area of expertise of various universities and research institutes in Switzerland. How does the government play a role in encouraging students to partake in the advancement of AI technology?

Artificial Intelligence is offered by many Swiss universities and no encouragement is needed for the students to develop their interest. Al skills are high in demand in the private and public sector. It is interesting to know that Switzerland has indeed the highest number of Al companies per capita in the world.

Recognizing the fact that science and technology is reshaping our lives, the Swiss Government founded in 2019 the Geneva Science and Diplomacy Anticipator (GESDA) with the aim to anticipate, accelerate and translate into concrete actions the use of emerging science-driven topics. The idea was based on the growing awareness that the world is experiencing breakthrough science and technological discoveries at an unprecedented speed and that these breakthroughs will reshape how we view ourselves as humans, how we relate to each other in society and how we care for our environment. Also, that humanity, especially people living in less-advanced or emerging countries, cannot afford to miss the potential of those science and technology advances for global wellbeing and inclusive development.

DICT envisions connecting more provinces and municipalities through partnerships with private companies for fiber connectivity projects. How will it be executed and maintained?

Private Sector Partnership (PPP)

- The private sector is an indispensable partner of the DICT to achieve our mandate. To foster partnerships with the private sector, the DICT now focuses on developing the necessary legal and institutional framework to address the gaps and focuses on comprehensive and more relevant strategies to forge stronger public-private partnerships. Together with PPP Center, the World Bank, Japanese International Cooperation Agency (JICA), and United States Agency for International Development (USAID), and other agencies - we aim to open opportunities for collaboration in the areas of capacity-building, creating markets and opportunities, and financing for digital infrastructure.
- In the area of connectivity, the DICT heavily relies on the aggressiveness of the private sector in continuing to lay down digital infrastructure in place alongside government initiatives through the DICT.

- To remain even more competitive, we strive harder to train and provide more opportunities for the Filipinos by aligning their skills with the requirements of the industry. Free online training and webinars are also being offered by the DICT and its Regional Offices to advance the digital literacy of Filipinos. For this, we have our Digital Jobs PH, which aims to provide basic digital literacy and intermediate ICT skills training in the Philippine countryside. With the help of our Regional Offices, we will be able to significantly reap the benefits of these initiatives.

Are there ongoing and planned initiatives by the DICT to further promote improved and increased investments in the ICT sector?

• The DICT under my watch has carved out a special executive portfolio for ICT Industry Development. An undersecretary has been appointed for the first time to oversee the growth of the jobs, investments

and opportunities in the ICT sector, from ICT-BPM employment to digital careers, to jobs generated by tech-startups and all other investments leading to digital services and global employment. The DICT will undertake a more robust pitch for the Philippines as an ICT investment destination of choice for all digital services and products across all verticals, not just for voice services, but non-voice, complex ICT services and ICT engineering services. Our excellent communication skills, service orientation as well as the proactive support of the DICT for industry make the Philippines the perfect venue for ICT global services to thrive.

- DICT has always partnered with the IT and Business Process Association of the Philippines (IBPAP) and its sub-sector associations in promoting and developing the country's IT-BPM industry. For the next 6 years, the DICT will adhere to the vision of the IT-BPM Industry Roadmap 2028 and will refer to the said blueprint as the Agency customizes its strategies and action plans for the sector.
- · The DICT shall focus on pushing for a more conducive investment environment for ICT and ICT-enabled industries both for local and international investors by exerting all our efforts to ensure connectivity, to ensure data privacy and cybersecurity and the presence of more skilled workers in these areas, as well as to help local government units in preparing their locations for ICT investments.
- The DICT will prioritize the proper implementation and application of data privacy and cybersecurity laws. This will entail a strong national advocacy on cyber literacy and more funding or investments in cyber protection and investigation.
- We shall continue to undertake more ICT investments trade missions inbound and outbound to promote the Philippines as an ICT destination and shall actively participate in international ICT conferences and exhibitions for various niche industries such as health information technology, animation and game development, electronics and software, startup development and many more. The DICT under our watch will include and train different digital champions and advocates from the countryside to pitch and promote their respective cities and provinces.
- We are in collaboration with policymakers and even our regional offices and councils to ensure that enabling legal frameworks and mechanisms are in place for a more business-friendly environment for our local and international investors. Last November 29, the DICT received the Ease of Doing Business Champion award from the Securities and Exchange Commission (SEC) at the Commission's 86th-anniversary celebration. This only affirms the Agency's proven dedication in fulfilling one of its very important mandates of promoting and enabling investment opportunities in the ICT and ICTenabled sectors, in partnership with both public and private organizations.

E-government and the order of President Marcos to transform the Philippine government into an agile <u>bureaucracy</u>

1. eGov Super App- Launched on December 2, 2022, is the Philippine's first one-stop-platform for local and national government services that will streamline processes and transactions; and to bring a total easeof-doing-business to all Filipinos. This initiative will avoid long lines and queues in government offices and make the Philippine government services available anytime, anywhere.

The e-gov superapp includes systems development, implementation, and integration of E-Local Government Units (ELGU), E-Government Application (EGovApp), EGovpay, E-Travel, E-Cloud, among others.

eGov App- Streamlining all local and national

eGovPay- Aggregating all payment channels and gateways in a single system. This will simplify and standardize all payment processing and transactions.

- **3. OFW App** The OFW app is in partnership with Department of Migrant Workers (DMW) and will contain the Electronic Overseas Electronic Certificate (E-OEC), making the processes seamless, contactless and effortless on the part of our modern day heroes.
- 4. The Government Employee Super App or GESA, in partnership with GSIS, will bring total ease of business to all government employees especially when it refers to transactions with the government social insurance system.

5. Improved Ease of Registering a Business through the Integrated Business Permits and Licensing System Software (iBPLS) / eBLPS

The Integrated Business Permits and Licensing System Software (iBPLS) is a cloud-based system that enables LGUs and their constituents to be able to transact and process business permits and other related permits, certificates, and licenses electronically or online. The Electronic Business Permits and Licensing System (eBPLS) software was developed and implemented by the DICT to enable Local Government Units and their constituents to apply for and process business permits electronically.

6. Secured Government Transactions and Enabled Digital Signing of Official Documents through the Philippine National Public Key Infrastructure (PNPKI)

PNPKI is a set of hardware, software, policies, personnel, and procedures needed to create, manage, and distribute digital certificates. This way, the government's delivery of services to citizens and businesses becomes safer, faster, and more efficient.

7. The Barangay Records Automation & Management System (BRAMS) is a free service under the Digital Government program of DICT Luzon Cluster 1 that aims to digitally transform barangays in the management of barangay records through an online web-based management system. It enables local barangay officials to maintain their resident records as complete and up-to-date as possible, and easily accessible for verification, monitoring and reference purposes.

8. Advancing Government ICT Innovation, Leadership, and Excellence (AGILE) Program

AGILE aims to promote LGU capabilities in terms of their ICT-related services and/or projects. Under the AGILE program are the annual Digital Governance Awards (DGA), the DGA Compendium, and the Digital Governance Conferences (DGC).

9. ilgu

DICT was able to pilot launch the Integrated Local Government System (iLGU) to implement an end-toend business registration with LGUs for Business Permits, Clearances, Real Property Tax, Business Tax, Civil Registry, and other permits. This will remove long lines in the City and Municipal Halls and streamline citizens' transactions with LGUs. Currently, there are around 906 LGUs (signed memorandum of agreement) that will implement the Integrated Business Permit and Licensing System. The iBPLS is just one module of the iLGU.

10. Philippine Identification System (PhilSys)

The Philippine Identification System (PhilSys) Act or Republic Act No. 11055 aims to provide a valid proof of identity for all citizens and resident aliens as a means of simplifying public and private transactions.

. E-Government and E-Governance Bills

The DICT has pushed for the consolidation of the E-Government and E-Governance bills that were filed before the two (2) Houses of Congress. While similar in objective, the bills differ in the platforms they sought to be established to achieve the digitalization of the government. At present, the bills are due to be threshed out in a meeting of the Technical Working Group (TWG), duly constituted by the House of Representatives. The E-Government/E-Governance bills shall be crucial in transforming governance to one that is digital and devoid of red tape and bureaucratic inefficiency.

These initiatives will focus on four clusters: industrial, manufacturing and transport (IMT); technology, media and telecommunications (TMT); health and life science (HLS); and modern basic needs and a resilient economy (MBNRE).
