EUROPEAN UNION TRADE AND INDUSTRY

The European Union's status in the global economy renders it as being the biggest player in the global trading stage and stands as an outstanding business region. A key understanding in the EU's attainment of such a position is its strategies on trade, where the EU has cooperated with one another rather than committing to separate trading strategies on the global stage.

Through increasing its windows of opportunity for investment and trade with the world, with an emphasis on sustainable development, the EU finds success in the global market and is classified as having the largest economy in the world. With the EU's commitment to free trade and open economies, the EU has garnered significant statuses and achievements in global markets:

- The biggest trader of manufactured goods and services is the EU, consequently, the EU is the biggest trading bloc in the world.
- In terms of both inbound and outbound foreign investments, the EU tops the ranks.
- Among 80 nations, the EU remains the top trading partner.
- The EU is the most open with regard to its imports from developing countries. Excluding fuels, the EU imports more from developing countries than the combined imports of the USA, Canada, China, and Japan.
- The average applied tariff is significantly low for items imported into the EU. Over 70% of imports pass through the EU with little or • minimal tariffs.

CAPITAL

Geographical Location: The EU is found within the continent of Europe, bordered north by the Arctic Ocean, west by the Atlantic Ocean, and south by the Mediterranean and Black Seas. In its eastern boundary is the Ural Mountains which span north from the Arctic Ocean to south through Russia.

Climate: The European Union region has a variety of climates, including arctic, drv, temperate, and humid continental climates. Northern regions have chilly winters and mildly humid summers, middle and eastern regions have cold winters and hot, dry summers, western regions have mild winters and humid summers, while southern and middle eastern regions have a Mediterranean climate.

Official Language: The European Union has 24 official languages, yet English, French, and German are most commonly used in business proceedings

Government Type: The European Union is governed under the ideals of representative democracy, with the European Council and the Council of the European Union representing the Member States, and the European Parliament representing the citizens.

Standard of Living: The Human Development Index (HDI) calculates the average HDI value for the EU in 2021 at 0.896 points. Denmark had the highest value of 0.948, while Bulgaria had the lowest with 0.795

Organizations: The EU consists of seven decision-making bodies that act as institutions responsible for working towards the EU's and the European people's common interests. These institutions are namely the European Parliament, European Council, Council of the European Union, European Commission, Court of Justice of the European Union, European Central Bank, and the European Court of Auditors. Under these seven institutions is an umbrella of EU agencies and organizations that assist the EU institutions in the fulfillment of their objectives.

- The Organization for Economic Co-operation and Development (1961)

FINANCIAL DISTRICT

The most significant financial district in continental Europe and an essential point for the stability of the financial markets is Frankfurt, with Germany being the largest economy in the European Union. It has a distinctive concentration of multinational banks, insurance businesses, national and European supervisory authorities, and lawyers. It contains an exceptional network of 202 banks (40 domestic banks, 162 international banks, and 33 representative offices), 7,900 financial services firms, and investment funds, as well as sizable branches of all the most renowned consulting firms, law firms, and auditing firms in the world. Frankfurt is home to the European Central Bank, the Deutsche Bundesbank, the EU insurance authority, and the Frankfurt Stock Exchange.

TOP 3 TOURISM DESTINATIONS





EIFFEL TOWER IN PARIS, FRANCE

More than any other nation in Europe or the rest of the world, France received 90 million tourists in 2019, making it the most visited country in the world. The Eiffel Tower, the emblem of Paris, is both a work of engineering genius and a well-known landmark. Visitors are awed by the tower's delicate airiness despite its gigantic scale and the spectacular perspectives at each of the three levels, which has given it the name "Iron Lady."

SAGRADA FAMILIA IN BARCELONA, SPAIN

Not far behind France, the second most visited country in the world is Spain with a record of 83.5 million tourists in 2019. The magnificent Sagrada Familia in Barcelona is Spain's most popular attraction and possibly the country's top tourist destination. It ranks among the most visited attractions worldwide. Visitors are mesmerized by this magnificent Gothic building's breathtaking beauty and incredibly distinctive construction, which combines Gothic and modern styles.



INTERESTING FACTS

- The European Coal and Steel Community was established in 1951 by Belgium, France, Germany, Italy, Luxembourg, and the Netherlands. This was given the name European Economic Community (EEC) in 1958 and was changed into the European Union as its official name in 1993.
- There is a motto for the European Union which states, "United in Diversity." The phrase represents how Europeans have united under the EU to work for peace and prosperity while also being enriched by the many varied cultures, customs, and languages of the continent.
- The "Ode to Joy" from Ludwig van Beethoven's "Ninth Symphony," which was written back in 1823, serves as the EU's national anthem.
- The Euro is the dominant currency in the EU, although not all nations have adopted it. 19 nations currently use it as their official currency. It was initially released in 2002.
- The European Parliament, which has 24 official languages, employs the most interpreters in the world with 350 permanent employees and 400 freelancers during the busiest times. Members of Parliament can communicate in their native tongue while still being understood thanks to the interpreters.



THE COLOSSEUM IN ROME, ITALY

Italy is the third-most visited nation in Europe with 65 million tourists in 2019. An iconic structure from antiquity, the Colosseum is extremely significant to Rome. It formerly served as the amphitheater for events like gladiator fights and even educational programs. It was constructed in 72 A.D. by Titus Flavius Vespasianus, who ordered the construction of the Colosseum as a present to the Roman populace. Its scale is so enormous that it must be seen to be believed; the construction was so grand that the entire structure took 20 years to be built

addition, more than half of the Filipino population is under 25 years old, which translates into an active workforce, which has the capacity to drive the economy forward. The Philippines also has a steady supply of highly skilled young professionals and workers that are able to accommodate a plethora of business needs. Lastly, the Philippines is the third largest English speaking country in the world, which is an important asset when doing business with Europe. One of the greatest strengths, however, is the commitment of the current administration to economic openness. There is a favourable sentiment towards globalisation and barrierfree exchanges, a key driver for knowledge transfer, the creation of jobs and overall economic growth. These elements altogether give the Philippines many advantages in comparison to ASEAN peers. The country would now benefit, in my eyes, of further consolidating its advantages and further work on the ease and costs of doing business, on sustainability and on the rule of law.

Since first arriving in the Philippines to take up your post as EU Ambassador, how have you observed the relations between the European Union and the Philippines develop and progress? EU-Philippine relations moved on extremely well in the last two years and a half. When I arrived in the country in December 2020, the world was in the middle of the pandemic. Our economies had taken a full blow and our main preoccupation was how to face the virus and how to cushion the socioeconomic fallout of the lockdowns. Europe was at the forefront in the development of a vaccine,

which was just going through the authorization process by the authorities. Once the vaccines were ready for use, the EU was again at the forefront when it came to making them available around the world. The EU also supported the Philippines by securing access to vaccines through the COVAX facility. The Directorate-General for European Civil Protection and Humanitarian Aid Operations (DG ECHO) also provided emergency response in the form of cash assistance, food packs, hygiene kits, temporary shelters, and makeshift isolation facilities.

Fast forward to today, while the Philippines continues to feel the effects of the pandemic, it is on a path towards robust recovery. The re-opening of the Philippine economy has led to strong domestic consumption, a dynamic business activity, and an increase in public investments; largely contributing to the country's 7.6% GDP expansion in 2022. The economy recovery also brought the economic relations with the EU back to pre-pandemic levels and even beyond. Indeed, total EU-Philippine trade in 2022 grew by 19.6% year-on-year to €18.2 billion. EU imports from and exports to the Philippines saw a growth of 29.9% and 7.6% respectively.

The EU was very happy to welcome President Marcos in Brussels in December last year. He came accompanied by a large business delegation. This was an important step in our relations and in further sharpening the profile of the Philippines in the EU.

While we learned to live with Covid 19, a new challenge came think both partners can work better together to achieve up in 2022. Russia's aggression against our neighbour, this vision? The government signed pertinent laws on economic liberalisation in the last year and a half, such as the Retail Trade Liberalization Act, the Foreign Investments act, and the Public Service Act. The implementing rules and regulations for the Build-Operate Transfer Law and Renewable Energy Act were also amended. These changes altogether further open up the economy to foreign investments. The effective implementation of these initiatives together with an improvement of the ease of doing business can help the Philippines become more competitive in the region, create better jobs and boost the transformation of the country into a greener economy.

In this context of multiple challenges, the well-established relationship between the EU and the Philippines remains unwavering. Together, we are stronger, and we should continue to work together to further strengthen our ties and uphold our common values. What do you find is the Philippines' greatest strength that would serve it best when doing business with Europe? What about with its ASEAN neighbours? The Philippine economy is one of the most dynamic in Asia. The country boasts a strong domestic market. In

What do you envision as the future of trade and investment relations between the EU and the Philippines? How do you

However, there is no reason to rest on one's laurels. As I mentioned earlier, still more can be done- from my perspective-to increase the attractiveness of the Philippines for traders and investors and bring the Philippines back on the map of EU businesses. I am in particular looking at the ease of doing business in the country. There is still a lot of room to streamline processes and requirements for investors and would-be-investors, room also to reduce the space for costly, lengthy and discretionary administrative decision-making including on taxation and on the issuance of permits and licenses. Moreover, improving the delivery of justice in the country and the possibility for foreign investors to get redress in case of commercial disputes would be a major plus. Transparency in regulatory processes is an important element that investors look for. Ease of doing business should not be limited to PEZA. Let me also mention that the Philippines rank low in international corruption indices, something that international companies are watching as due-diligence requirements become more and more stringent. I see clearly that the country is working on all these elements. As this happens, the Philippines will become increasingly a place where European investors want to be and from which European companies and consumers want to be supplied.

Moving forward, both parties should continue to work together towards maintaining the Philippines' GSP+ status. The EU also remains interested in a resumption of the bilateral FTA once the context is right.

What is the importance of having a strategic partnership between the EU and the Philippines most specifically in trade and investment?

The EU and the Philippines do have a Partnership and Cooperation Agreement since 2018. We have a broad agenda and this agenda is growing: as an example, we have just created a sub-committee dealing with maritime issues in all their aspects. The political conversation between the EU and the Philippines is a conversation among equals. We share values such as freedom and democracy and an unwavering commitment to the rules-based international order, including for example the law of the sea. We also have shared strategic interests such as peace and stability in the Indo-Pacific, freedom of navigation, climate mitigation. Trade and investment is definitely at the centre of our common agenda and of how we articulate our common strategic interests.

How do you think can Philippine exporters maximise the EU GSP+ scheme?

The GSP+ scheme is underutilised by Philippine exporters, and what the country offers for export to Europe is not very diversified. European customers value quality and steady supply once they have set their eye on a product. Moreover, the European market is very competitive. Europeans are ready to pay an adequate price, but they will move on if product quality is not kept up or if a product runs out of stock. In other words, in principle any product can be successfully exported into the European single market if these conditions are met.

I believe one main reason for the underutilization of the GSP+ is that Europe is far away, and it is difficult for smaller

exporters to market their product over such a distance, even if they have an excellent offer. There is also not much knowledge here about the market conditions in Europe and the legal requirements to import into the EU.

In line with this, the EU has been proactive in helping exporters maximise the privileges under the GSP+ scheme. ARISE Plus Philippines, an EU-funded project led by the Department of Trade and Industry (DTI), is a key tool to allow Filipino exporters to better take advantage of EU market access and the GSP+. We hope that this will maximise the use of GSP+ and support overall EU-Philippine trade.

To your view, what are the benefits of having an EU-PH Free Trade Agreement (FTA)? What is the current status of the FTA negotiations between both parties?

An EU-PH FTA would allow for an even more vibrant economic relationship through better bilateral market access, whether for goods, services or public procurement. By breaking down market barriers, it would encourage greater trade and investment. In addition, an FTA should improve the business conditions for investors from both sides, enhance the protection of intellectual property and promote good product standards, sustainability and a green economy. Such a framework then creates a ripple of job creation, know-how transfer, and economic growth. An FTA would also grant consumers access to more and better goods and services. What is also very important is that an FTA would consolidate the advantages that the Philippines currently enjoy through GSP+.

FTA negotiations with the Philippines were launched in December 2015. However, these have been on hold since 2017. We are hoping to continue talks once the context is right.

What are the EU's top priorities in its economic relationship with the Philippines?

The EU is, together with the US and China, the largest trader of manufactured goods and of services in the world. It also ranks first in both inbound and outbound international investments. The EU economy is to a large extent built on external trade. And this does not only mean exports. The EU industry needs high quality intermediate products and it needs commodities. These are areas where the Philippines have the potential to excel. At the same time, the EU industry has a lot to offer, which is also of interest to the Philippines. EU companies are amongst the world leaders in sectors like renewable energy, transport equipment, construction and infrastructure, environmental technology, health - just to name a few. Europe, through its investors, is the top world exporter of technology and knowledge. Millions worldwide work for EU companies, companies that are considered good corporate citizens in their host countries. Thus, given the potential of the Philippines that I mentioned earlier, I would say that one top priority will be to further facilitate trade and investment between the EU and the Philippines. Another priority is to put the Philippines back on the map of business in Europe and promote Europe in the Philippines. This is something we can only do jointly.

What are the plans of DTI on boosting Philippine exports?

Further, the PEDP 2023-2028 will prioritize the following strategic actions in developing the industry clusters: First, addressing constraints to production in terms of scale and scope by a) attracting investments to broaden and develop capabilities, facilitate technology and knowledge transfer, and create an ecosystem of suppliers in the country; b) capacitating firms to be able to compete beyond pricing and to amplify quality, value-addition, sustainability, and reliability of Philippine exports in the global market; and c) providing an enabling export environment that will allow businesses to thrive. Second, developing a strong and innovative export ecosystem by improving backward and forward linkages, increasing participation in preferential trade agreements, and providing institutional support.

We also aim to increase the Philippines' mindshare in the global market through targeted efforts to raise awareness of Philippine export capabilities and build the country's reputation as a reliable source of high-quality goods and services. Likewise, firm-level support is crucial to amplify the impact of industry-level interventions and continuously build a pool of exporters that will serve as frontrunners in driving Philippine export growth. This ties up DTI initiatives to develop enterprises and create a clear pathway toward exporting.

Further to this, we leverage on our existing and "on the pipeline" agreements with other countries to increase the market access of Philippine exports. Aside from the huge domestic market that we have, the Philippines offers access to the ASEAN market that has more than 600 million-population and other key markets through our Free Trade Agreements (FTAs) and Generalized System of Preference (GSP) with other countries and regions. For one, we have the European Free Trade Association (EFTA), which provides the country duty-free market access to all industrial and fisheries products to member states such as Norway, Switzerland, Iceland, and Liechtenstein. Tariff concessions were also secured on substantially all Philippine agricultural exports to EFTA. Likewise, we are the only country in the ASEAN to benefit from the European Union's (EU) Generalized Scheme of Preferences Plus (GSP+). In addition to this, the Philippines has other FTAs including the recently-concluded RCEP, Philippines-Japan, and ASEAN FTAs. The Philippines has been a beneficiary to other GSP schemes including that of the UK and the US, making the country more attractive as a manufacturing location. Last year, we also concluded the negotiations for the Philippines-Korea Free Trade Agreement, this focused on market access for Philippine banana exports and for Korean automotive units and parts.

What are the strategies of DTI to support micro, small, and medium enterprises (MSMEs) to get back on track and adopt new changes from the challenges it faced during the height of the pandemic, as well as increasingly volatile global and local markets?

Innovation plays a crucial role in enhancing the competitiveness of MSMEs, allowing them to seize new opportunities, develop unique products or services, and differentiate themselves in the market. To support innovation within MSMEs and startups, the DTI implements various measures such as the Innovation for RIICs, Industry, and Startups (IRIS) Project, which aims to foster inclusive and sustainable industrial development in the Philippines through programs that will build and strengthen the innovation and entrepreneurship ecosystem in the regions, facilitate the adoption of Industry 4.0 technologies, and support the growth and development of startups and the startup ecosystem as a whole. We also have the SMART (Strategic MSMLE & Startup) Link that aims to match leading-edge innovative startups in the Philippines with commercial products to traditional enterprises or Micro, Small, Medium, and Large Enterprises (MSMLEs) through the conduct of business-to-business matching sessions or Smart Link sessions. This aims to facilitate partnerships and collaborations between startups and traditional enterprises.

Likewise, we have established Shared Service Facilities (SSFs) in different areas within the country, which are meant to improve MSMEs' competitiveness by providing machinery, equipment, tools, systems,

a shared system. This shall help them improve the quality of their products and increase their production capacities or capabilities. The SSF is a public-private partnership through cooperators that are capable of housing the machinery and equipment, enabling these facilities to be accessible to MSMEs.

As previously mentioned, DTI is also working on the integration of industry development, trade, and investment, which plays a pivotal role in developing our MSMEs. Through this, linkages will be established and value chains will be optimized, enabling MSMEs to unlock new opportunities to overcome challenges more effectively. Currently, the DTI has programs that aim to promote MSMEs' access to international markets and integrate agri-based MSMEs into the global value chains such as: (1) Tradeline Philippines: Export Data and Service Portal; (2) Regional Interactive Platform for Philippine Exporters (RIPPLES); (3) Rural Agro-Industrial Partnership for Inclusive Development and Growth (RAPID GROWTH); (4) Comprehensive Agrarian Reform Program (CARP); and (5) Coconut Farmers Industry Development Plan (CFIDP)

We have also launched programs in support of MSME products, enabling them to reach wider markets, earn bigger profits, and penetrate the mainstream market. We have the One Town, One Product (OTOP) Program, which aims to promote entrepreneurship and product development at the local level, encouraging MSMEs in various regions to showcase their unique products and craftsmanship. The DTI provides capacity-building support, product development, and branding assistance to MSMEs participating in OTOP. Aside from this, we have the Go Lokal!, a market access platform for MSMEs, assisting them in entering the mainstream market via free services offered by the DTI such as merchandise development assistance and market access to stores/spaces provided by DTI's retail partners.

Again, as mentioned earlier, under my leadership, we aim to pursue digitalization. We assist MSMEs in adopting new technologies. enabling them to keep up with the ever-changing market dynamics and landscape. We are implementing the MSME Digital Maturity Toolkit and Training Framework that helps MSMEs assess their needs and provide recommendations on possible digital transformation training frameworks capacity building. We have the CTRL + BIZ Reboot Now! Program, a series of webinars and trainings aimed at providing MSMEs with information on starting their business online, connecting them to enablers and enhancing their skills to meet the needs of the e-commerce market. This was started in April 2020 as a response to the market demands created by the COVID-19 pandemic. Aside from these, we are currently developing an e-commerce platform in collaboration with the private sector that aims to provide MSMEs with a platform where they can sell their products online. This will showcase an online storefront and will enable them to reach the mainstream market and earn higher profit.

What are the common problems that DTI faces with regards to the protection of domestic industries from importation surges?

The DTI promotes free and open trade in the country and among its foreign trade partners. We carefully balance our commitment to the multilateral trading system and the interest of our domestic industries.

As a member of the World Trade Organization, the Philippines is provided with a trade policy tool which allows the government to take remedial action against surge in imports which causes or threatens to cause serious injury to the domestic industry.

The DTI is committed to level the playing field for our domestic industries in order to increase the manufacturing base in the Philippines. Accordingly, the Department has issued an Order imposing the definitive safeguard duty on imported High-Density Polyethylene (HDPE) pellets and granules from various countries for three (3) years. There is also an ongoing preliminary safeguard measures investigation on imported liquefied petroleum gas (LPG) cylinders. All these are initiatives aimed at protecting our own industries.

Huge Fines

The GDPR brings in the possibility of imposing hefty fines of up to 20 million EUR or 4% of the global annual turnover, whichever is higher. This is a substantial change compared to the previous administration's limited sanctioning ability. The fines imposed under the GDPR are intended to be a deterrent to organizations that may be tempted to violate its provisions. The large fines reflect the seriousness with which the EU takes data protection and privacy.

Real Reputational Risk

As a result of the increased enforcement activities, data protection breaches are more likely to be identified and reported, leading to a higher risk of reputational damage for the organizations involved. Data protection breaches can severely impact individuals' privacy rights and can result in an organization's loss of revenue.

Under the GDPR, organizations must report data breaches to the relevant supervisory authority within 72 hours of becoming aware of the breach, unless the breach is unlikely to result in a risk to individuals' rights and freedoms. Failure to report a data breach can result in significant fines.

Large Geographic Reach

The GDPR's geographic reach has expanded the legislation's authority by bringing more organizations under the scope of EU data protection regulation. It is now extended to "all organizations offering goods or services

Membership Rounds in CDO: Northern Mindanao Federation of Dairy Cooperatives 26 April 2023

The Northern Mindanao Federation of Dairy Cooperatives (NMFDC) is one of ECCP CDO - Northern Mindanao's first members wayback in 2018. The federation has a milk processing plant located in El Salvador, Misamis Oriental. Their products, called the Highland Fresh, include flavored milk, famous and top-selling milk bars, butter, etc. are all out in all the supermarkets of Misamis Oriental and Bukidnon and are made from pure cow's milk. The brand has also been regularly supplying Gouda Cheese to Philippine Airlines for many years now.

Currently, the total milk production of the Philippines is only at Seven (7) percent. A total of 1,800 dairy cows will arrive in the country as part of the initiative to increase milk production, and they will be distributed to farmers in various provinces. Last March 21, 2023, the Department of Agriculture turned over an ESL (Extended Shelf Life) Pasteurizer Set which would extend the shelf life of milk from 7 to 30 days with Homogenizer, Standby Generator Set, Air Compressor, and Refrigerated Van as part of the Dairy Milk Processing and Marketing Enterprise initiative to boost the optimism that the nation's milk production would expand significantly.
