DENMARK TRADE AND INDUSTRY

POPULATION

5.92 M

Denmark is known for its high standard of living, supported by its growing economy. Most of their economy relies on service-based industries, trade, and manufacturing. In fact, Danish exports consist of food, machinery, instruments, and packaged medicaments.

As of 2017, Denmark was ranked as the 38th largest export country in the world, and the 19th most complex economy. With its strategic location, Denmark has taken advantage of its maritime trade, but has also explored trade through land transportation as well. Some of their top major import partners are Germany, Sweden, the Netherlands, China, Norway and the United Kingdom.

The top 2 Industries in Denmark are Finance/Insurance/Real Estate and Services. In that particular order, the Finance industry holds 38.8% of Denmark's market share, and the services industry holds 38.6%. In terms of the dominating finance sector in Denmark, much of the established banks (regulated by the government) are located in Copenhagen. Although a member of the European Union, Denmark's main currency is the Krone, and has not voted to adopt the Euro (the common currency of the EU). On the other hand, the services industry mainly focuses on the ever growing tourism sector, and a substantial amount of the services provided are mostly in public administration, education, social and health services.

Geographical Location: Denmark is currently located in Northern Europe between the Baltic and North Sea. It also includes the Faroe Islands and Greenland in the North Atlantic. In fact, its location is attractive for business opportunities as it connects the whole of Europe, the Scandinavian, and the Baltic nations together; creating a trading link for markets that hold millions of consumers.

Climate: The climate in Denmark is moderated by the warm gulf streams, therefore the weather isn't as intense as their Scandinavian neighbors. In addition to that, the country also hosts 4 seasons; the coldest seasons are December to March, whereas the hottest months are June, July, and August.

Official Language: Danish serves as the official language of Denmark. However, there are several minority languages spoken throughout the territory, if The Faeroe Islands and Greenland are included.

Government Type: Denmark runs as a Parliamentary Democracy. Also known as the Folketing, it also runs as a multi-party structure. Within the multiple parties, the strongest party representative will run as the Prime Minister, and these parties also negotiate in order to form a coalition with each other. Elections for the Folketing are held every 4 years, but the Prime Minister may choose when to hold one at any time. Finally, although the Danish Queen runs as the head of the government, her role is mainly conventional.

Standard of Living: Denmark is known for its high standard of living for its citizens, outperforming in terms of job opportunities, education, health, environmental quality and more. The average household disposable income per capita is USD 33,774 a year, with about 74% of the population aged 15-64 working paid jobs. In terms of life expectancy, it averages around 82 years old, a year higher than the world average, which is 81 years old.

Organizations: Denmark holds a lot of importance in terms of participating in international development cooperation, making them active players in addressing cross-border, global challenges. Some of the multilateral organizations Denmark is participating in are the European Union, United Nations, World Bank, Global Environment Facility, Organisation for Economic Co-operation and Development, African Development Bank, Asian Infrastructure Investment Bank, and finally the Asian Development Bank. Denmark's engagement and contribution with the international organizations hopes to address global challenges such as human rights, environmental protection, widespread poverty, and more.

FINANCIAL DISTRICT

The main capital of Denmark, Copenhagen, hosts the main business/ financial hub of the country. In fact, Denmark is known as the #1 European country to invest in for future business owners, with key industries ranging from clean technology, life science, and food. Copenhagen also holds many of the countries' major banks, like Danske Bank, Nordea, Jyske Bank, Syd Bank, and more. In addition to that, Danske Bank has enabled growth and development in society, and has provided support for businesses and individual citizens in Denmark alike.

THE FAROE ISLANDS

Situated in the North Atlantic, The Faroe Islands are an archipelago of 18 islands that were shaped by volcanic activity and the glaciers of the ice age between Iceland and Norway, but are under the Kingdom of Denmark. Most of its economy depends on tourism and its fishery exports, in fact, a lot of tourists visit the islands for its incredible natural beauty. Many visitors from all over the world come to hike and bird watch around the coastal cliffs.

A popular recreational attraction for tourists, Tivoli Gardens was an inspiration for many of the modern Disneyland parks, and holds many fun attractions such as roundabouts, roller coasters, food pavilions, a Moorish-styled concert hall and more. - Denmark is known for being one of the happiest countries in the world, as reported by the World Happiness Report. Denmark's friendliness and progressive culture makes it a worry-free place to stay in. Their concept of happiness stems from the word "hygge", pronounced as "hyoo-gah", which describes the feeling of comfort you experience when you're together with family and friends.
- The world-famous building-toy, LEGO[®], was actually a Danish invention. The name LEGO® originated from the word "leg godt", which means "play well". LEG0® started off as a wooden toy company, but by 1947, they introduced the well-beloved, popular, interlocking colorful plastic bricks we know and love today.
- The harbor in Copenhagen is so clean, you can actually swim in it. Copenhagen Harbor has 3 main areas, Nordhavn, Inderhavn, and Svdhavnen. The city's most popular area to swim in is Sydhaven, where you'll find the island's Brygge Harbour Bath.
- The Danish royal family is one of the oldest existing monarchs in the world. Their family ancestry can be traced back to the 8th century, and the current Danish Monarch, Her Majesty Queen Margrethe II, is the head of state
- Denmark's flag is the oldest national flag of the world still being continuously used. According to a legend, the Danish flag, also known as Dannebrog, fell during the Battle of Lyndanisse against Estonia in 1919. It was then the Danish King Valdemar II won victorious amidst his drive to the rest of the Baltic states.
- Known for its progressive and open culture, Denmark became the first country to legalize same-sex marriage. Same-sex partnership laws were first introduced in 1989, and in 2012, the parliament legalized same-sex marriage, allowing equality for all marriages.

Interview with the Ambassador of the Kingdom of Denmark to the Philippines

H.E. Franz-Michael Mellbin

Since first arriving in the Philippines to take up your post as Danish Ambassador, how have you observed the relations between Denmark and the Philippines develop and progress?

Ambassador Franz-Michael Mellbin: We have seen very good progress in several areas and I'm very happy to see the growing interest from Danish companies in the Philippines, so that more investors are coming here. We had a great breakthrough. The Philippine government changed the rules for foreign ownership of renewable energy assets and that led to commitments by the Danish investor group for over \$5 billion into the renewable energy sector hereby far the largest commitment we've seen from the Danish side so far into the Philippines.

But certainly, also in a number of key areas where we are active, we're seeing progress. We are looking at the agricultural sector where we have already had several visits and are planning more for next year. In the energy sector, we have not only these investments coming in but also stronger cooperation with the Philippine side, which we'll also see during COP 28, which is going on as we speak. We are happy to share the progress also within the maritime area, which of course is a key area for both our countries. We are also picking up speed in the defense sector, due to strategic reasons, which has taken up a lot more space recently, both in Europe and here in the Philippines.

But there's much more work to be done to change that. There's also a challenge with energy prices. If you're looking at manufacturing certain strengths for the Philippines, including the digital area, the back office success story of the Philippines is widely understood.

Danish companies employ thousands of Filipinos in back office operations, which of course is a great thing. We also see more IT services moving out from Denmark to the Philippines. This is a continuing process and it is a real strength for the market and for the economy on the service side. Speaking of service, the addition of having an Englishspeaking labor force is a huge advantage also. However, there are also peer pressures from your neighbors, at least when it comes to educated staff. So you must have people who either have an academic background or high school background, or are increasingly fluent in English.Whereas, in fact in the Philippines, the trend line is down and the Philippines really needs to have to think carefully about where it's going with its education sector because this is a strength.

What do Danish businesses find most attractive about doing business with the Philippines and what are their main considerations in entering the Philippine market?

What efforts have been put in place to expand Danish companies across the Philippines and if there were any challenges faced by these companies, can you share a bit about that?

Ambassador Franz-Michael Mellbin: One of the instruments we have is our export promotion credits which are looking more closely at the Philippines and the fact that they want to do more here, and I think that is a good stepping stone. There are some companies that are very used to using that instrument and we also recently had a seminar together with Sweden, Switzerland, and the Netherlands about how these credit facilities work. Denmark has the next oldest in the world of these export credit facilities. It's a very modern, very flexible instrument and we can use it for various things. So that has sort of been put in place.

We also have something we use that we have either already entered into or are pursuing with the Philippines. One of those is digitization that has not been signed yet, but I'm still hoping we can sign this year and that will also open new venues for Danish companies to work with the Philippine public sector. Denmark is the world's leader in public IT and IT solutions. This is a main priority for the Marcos administration. We really want to do more together with the Philippines in that space and Danish companies are ready to enter the market to do that as soon as we have the MOU in place.

There are a wide range of sectors, key things, if we look at the challenges. You also asked about what the Danish companies might be facing out there and the three main things that I'll mention which are quite important to Danish companies as they look upon the Philippines. The first is that the economy suffers from low productivity. Now that is an opportunity. If you, as a foreign company, come in with world class or leading productivity, it's like picking up gold in the streets. I mean, there's just a huge gap in many sectors. Between the productivity, agriculture is a good example of this. The agricultural sector is under invested. It is underperforming for that reason.

There are, of course, huge opportunities. The Philippines used to be a leading exporter in the world of agricultural products. It used to be the largest rice exporter in Asia. It used to be the world's largest coffee exporter. I don't think anybody even remembers that you would be the world's largest coconut exporter and cocoa exporter. I mean, all these strongholds sort of went out because of lack of investment and thus, lack of productivity growth. But there is a real opportunity there. Another thing that Danish companies look at and would sometimes worry is the lack of productivity, if you are dependent on suppliers, and supply chains inside the Philippines. You worry about low productivity in the market because that is higher prices and less quality. So that is something they look at also from that point, it's not just an opportunity to make money. By replicating what you're doing elsewhere, it's also dependent on the system here, and the infrastructure plays a role.

The other big chunk is governance. Governance is a real issue. It's closely linked to bureaucracy and red tape, of which I'd say the Philippines is extremely innovative. I always use the example with my car. I arrived in the Philippines 1 1/2 years ago. My car still does not have number plates. It's not lack of trying, it's just hypocrisy. It's difficult to describe for people who haven't sort of experienced it. I have a whole staff to help me. I don't know how ordinary people manage those things, but for me it's taking more than a year and I still don't have my number plates for my car. So it's just a colloquial example of what you might face.

Customs is well known and not always admired. Part of that bureaucracy also worries investors. Governance is a real problem and it needs to improve a lot of steps the government could take. I do hope that we'll see the government push more in this direction given that the President has stated his intentions. We need more action on the ground to improve that.

So the third area I'll point towards is infrastructure. There is a huge need for better infrastructure. The government is aware they are investing heavily in infrastructure. I think NEDA and the Department of Transportation and others are actually doing a very good job. They know what is needed. You are behind the curve on infrastructure, so it's good that there are huge investments there. In this area you will become a richer nation because of these investments. As a foreign investor, we have to think carefully about how to manage the current infrastructure challenges and what will it look like further down the road. We do see a lot of promising projects ongoing in the country and I think that will be a real boom to the economy overall.

What do you envision as the future of business and trade between Denmark and the Philippines, and how do you think both partners can work better together to achieve this vision?

Ambassador Franz-Michael Mellbin: I remain an optimist. I do believe this will be the decade of the Philippines. I think the Filipino people deserve it. You have watched your neighbors sort of move into high gear. It's high noon for the Philippines to do the same and experience the kind of growth that you've seen. Projections are very optimistic if you look at the ADB and World Bank numbers of 6-7% in line with government estimates over the next decade, effectively double the economy over the next decade. This is a great departure point so I am very optimistic we will see more Danish companies doing more business here and with the Philippines.

The free trade agreement with the EU could be another boost. I very much hope that it will continue to move forward. I've been very impressed both by the European side and by the Philippines side, how quickly it was possible to re-engage on a free trade agreement and get things moving. To me, it signals that both sides are earnest about reaching an agreement. The Marcos administration has been able to come to the table well prepared in spite of the long hiatus after the negotiations were stopped for several years ago now. So this to me is a past design and of course that will be helpful.

This will also send a signal to European and Danish companies about the economic opportunities and the relationship with the Philippines. Also, removing some of

A lot of people willknow Mercedes, Rolex, Airbus, but they will never have heard about Nordisk, in spite of its tremendous size, butbecause it's a pharma company. Unless you're sick and use their products, you won't know it, of course. The effects have sort of a footnote or is on the world map for a while at least, but otherwise a lot of people don't know a lot of these things - companies, instruments, for example, are technical instruments. We have several Danish companies that are absolutely world leading, but unless you're in a business where you use those tools, you won't have a clue.

If you go to a country like Vietnam, they are facing a challenge now with some manufacturing companies forgoing Vietnam, in spite of guite a lot just think that is an amazing story of how you have turned of advantages, due to their broad based supply lines. This is an interesting development. Denmark has a lot of energy technologies. We have a lot to share when it comes to reducing energy usage which is a very large part of becoming more sustainable. Reducing your energy consumption is the best way.

Energy you don't buy and don't use is the cheapest energy and the cleanest energy, no comparison. I'm very happy to have heard the president and the environmental minister all say, the energy you save is the first few so energy savings out. First few it's a great thing and Denmark does have leading technology here. We can do a lot with the energy wastage. The lack of understanding of how to manage energy in this country is quite worrying. It also gives a lot of opportunities. I think there needs to be a lot more awareness on that. Then there's the question of how do you optimize your productivity in a way that it also makes your production more sustainable? Denmark has a lot to offer here. We have very strong advisory and consultant services who understand how to do this, so I'll give one example.

One of the areas which takes up a lot of energy is wastewater treatment. This is a high energy cost and basically a high cost sector, so it costs a lot to deal with waste and all things. But in Denmark, we now have two waterworks that are called resource harvesting centers. So they're not waste water processing centers, they are resource harvesting centers and they actually produce a surplus of energy. This is just going in, optimizing what you're doing and simply changing the equation and these things can be done. It's really optimization process.

The third area where I can see a lot of opportunity here is when it comes to the circular economy and how the Philippines can become much better at reusing and recycling, while also taking more careful care of the resources it has. And we all know waste is a huge problem in this country. It pains me to see Philippine forests, beaches, sea, rivers, lakes polluted with all kinds of things. There is a better way and it can be done in a more efficient way. It's really about political will.

The Philippines can do what a lot of other countries have already done, including in the region, and it will be for the benefit of Filipino people and it will be beneficial for future generations. Denmark does have solutions to offer here. I think overall, Europe is in a strong position to help. It is about getting the politics right and using the example of waste management. It's highly politicized in the Philippines because it's a money bank for certain groups and that is not conducive to optimizing the results. You need political will to change that.

When it comes to the circular economy, I think that it's really about knowing how and understanding better what can be done and how do you actually go there. In Thailand, they have the world's largest tuna factory and so there's a very large tuna producer. They produce a lot of tuna products there, including canned tuna. They actually found

One of the reasons why President Marcos really wants out that if they took the waste material, the leftovers you can't sell to consumers like the heads, tails, and bones, the skin products, etc., and they mix that up with enzymes from one of these Danish enzyme companies, the value of that is now higher than the tuna they're selling. And I a waste product into a huge competitive edge, but also a huge profit which nobody had imagined. You just usually threw these things out, but now it has found productive use. There are solutions like that which people simply don't imagine because they don't have the knowledge or the know-how.

> This is where Danish companies, Danish advisory and consulting, come in and point to world class solutions. But not always from Denmark necessarily. I'd like to make a short plug for food waste in Denmark. We have been very good at reducing food waste in Copenhagen. It's dropped dramatically. I believe it's down to half of what it used to be, a precipitous drop in food waste.

> Again, this is an organizational skill. There is a Danish company that made an app which helps consumers meet producers and providers that makes food waste accessible because it needs to be saved. Food is perishable. That can also be done here in the Philippines. Indeed, there is a Danish charitable organization which is now organizing large scale food saving. They call it food rescuing which they have done in Thailand and they feed hundreds of thousands of people through those programmes. That can help some of the poverty stricken Filipinos, which are in dire need of all the help they can get.

> It's a good business case. I find this very difficult to understand. You go into a hotel lobby and it's 16 degrees and I'm thinking, if you turn up to 21 or 22 degrees, which is actually a very nice temperature, you're going to save half your electricity bill if you're a hotel manager. Why are you not? Changing the temperature in your lobby is an easy thing to do and the savings are huge. These things I'm curious about and it is an awareness issue. In Denmark we were not good at saving energy back in the 70s. But with public information and education, now Danes are very good at it and we're saving energy. Water consumption in Denmark, in spite of becoming richer since the late 70s and the beginning of the 80s, have reduced and the economy has expanded a lot since then. Water consumption has been reduced by 40%. Just imagine.

Can you highlight any ongoing or upcoming collaborative initiatives between Denmark and the Philippines that promote innovation and sustainability and commercial interests?

Ambassador Franz-Michael Mellbin: If we look at the six sectors as I mentioned before, we're looking towards the MOU on the digital side. We are looking towards having more visits on the agricultural side, so there will be more exchanges in that sector. We have invited the Philippine Navy and Coast Guard to visit Copenhagen to learn more about how we manage our own defense, but also to look at the defense technologies that will potentially allow the Philippines to have more situational awareness over areas such as the West Philippine Sea.

We are also looking right now at the export credit facility and are about to sign an umbrella agreement with the

Ministry of Finance. And for the companies, the big question now is how fast can we integrate AI into? What are we doing? I have been impressed so far by how fast the English companies have started to look more closely at Al and already are developing Al based tools into their production because at the end of the day, AI is about increasing productivity. And one of the reasons why our economy is so strong and has been able to grow so much as it has over the last years is due to they erv strong productivity growth led by the private sector. That is a key to bringing welfare and jobs to all things.

If you look at foreign direct investors in Denmark, we have guite a lot coming to Denmark investing there, including FDIs. It's very interesting to note that on average, FDIs in Denmark are 25% more productive than the Danish companies, so they bring a lot of competitiveness into the Danish market. Now, the Danish economy is one of the most productive in the whole world. So you're almost up there in the number one spot. You can look at different models and some will say we're #3 or will say to someone it's not very important. It's up there at the very, very top and then you have to imagine that foreign direct investors in Denmark are 25% more. It's not like a few percent, it's a gap. Just imagine the productivity gap in the Philippines which is much less.

This born global concept is an important one. If you have a local 7-11, you know you're not feeling that globalized pressure. So I'm not going to say it's 100% of the economy because it's not. There's parts of the service industry that won't be, but a very large percentage of even small, medium sized companies are born global and we can see that they are good at it. If you look at robotics, where Denmark is larger than 100 in Denmark, you are a large company. It's quite interesting if you go to Germany, I think the cut off is 2000. You're not a large company before you passed. It just says a lot about the industrial structure of Denmark. We have a few giants with hundreds of thousands of people, but a large proportion of our industrial strength and service strength lies with very small companies.

I'll give another example. We have a company that delivers software for flight control and they are leading that niche in the whole world. I met the owners and I asked them about the software and how they're selling to New York and Frankfurt and Heathrow and all these other channels, even China. Everybody more or less uses Hong Kong or Singapore-made software. I asked them about their company and there are three people there. Yes, that was the company and it just went out there and sold the stuff to the world. That's a very small company that found a very specialized niche that a lot of bigger companies may not take a big interest in, but it just shows that specialization is very close to what Danish entrepreneurs are looking for.

They have this idea in their head. If they're going to be successful, they have to scan not just what's around the corner. They have to scan out into the world and see what's best out there. And can we be even better?

I think you have lots of opportunities and I really mean it when I say let's make this the ticket of the Philippines. There's no reason why you haven't had your breakthrough except for bad policy. I mean bad politics is really the pain of the Philippines and the Filipinos. You deserve to be in a much better place. Go there. It's not just going to happen. You're going to have to work for it.

We didn't talk a lot about education. I did mention with the English skills. I worry about education in the Philippines. We need to invest more, we need to mobilize more effort on the educational side. Otherwise you're going to hit a level of economic growth and welfare. Then you're going to level off because you're going to lack the people to take the next step. Don't do that. Educate your young people. Nothing drives the economy more than smart people. We didn't talk about this, but let me mention on the innovation side, I think it is important we import a lot of talent to Denmark. A lot of talent comes to Denmark to work there and it really helps our competitiveness. Having smart people, it can't be beat.

How does Denmark see itself in influencing the digitization of small and start up Philippine businesses in both nations?

Ambassador Franz-Michael Mellbin: We really want to work closely with the Ministry of IT and the public sector here. I think where we can do most is on the public sector side. We have solutions for private companies, but typically these people are already our customers and so we won't be introducing anything new. I'd rather say we'll sort of be honing the digital skills of what's in the market. You have a lot of companies here who have a very low degree of digitization. There are a lot of reasons for that, amongst others, insufficient internet infrastructure, too high prices and too slow speeds. It just doesn't make for a very good combination. But also because the public sector doesn't offer a lot of important services, haunted tour platforms and that needs to change.

on red tape. It will increase governance levels. So there's a lot to be done there. It can also increase productivity overall. I do hope we will see a much stronger cooperation between Denmark and the Philippines here. I believe some we have made, which would have been exported around the world to all kinds of countries, like UAE, Germany, U.S., UK et cetera. can be hugely beneficial but the lack of infrastructure is a problem for your small and medium sized enterprise. It's a cost and it's annoying. It's annoying for everybody because it is expensive and slow and all that. But the big ones, they manage that. They take it as an extra cost, and that's annoying but they can manage it. For small and medium sized enterprises, it holds them back. And you know you can easily have talented people here who also can start developing solutions and be part of that global market. But if they don't have the opportunity to work and grow here, your best people are going to go abroad and that's not helpful.

Do you have any parting message to the readers of the EU-PH Connect for this issue on innovation?

Ambassador Franz-Michael Mellbin: Education is absolutely key. It starts with elementary school and grows all the way up to college. The Philippines needs to invest more, but also Philippine companies have to help the state drive education forward. If there is a need for concerted effort from the government, from companies but also from Filipino families who are wishing for a better future for their children, bet on education. It's the best investment you can make in your life and that will drive innovation.



Interview with the Department of Science and Technology Secretary

Hon. Renato U. Solidum Jr.



How do you plan to scale up the country's technology adoption, utilization, and commercialization while making it market-driven and competitive?

To scale up the country's technology adoption, utilization, and commercialization, the Department of Science and Technology (DOST) will do the following:

- ✓ Paradigm shift in doing research and development (R&D) to push for more market driven/need-based approach for relevance and suitability of technologies developed;
- ✓ Intensify further government-academe-industry collaborations in R&D for seamless transfer of developed technologies or services;
- ✓ Capacity building of partner institutions on Intellectual Property (IP) protection, packaging of technologies for promotion, and technology transfer;
- ✓ Review existing policies and guidelines to make services more conducive for business sectors without sacrificing the objectives of the government;
- Strengthen partnership with other National Government Agencies (NGAs) and other stakeholders for support in the deployment/transfer of technologies
 building capabilities of technology adopters to scale-up commercialization of technologies;
- ✓ Encourage researchers, scientists, and engineers (RSEs)/technology developers to venture into spinoffs or startups while infusing technopreneurship;
- ✓ Sustain the implementation of the following DOST programs:
 - Startup Grant Fund (SGF) Program The DOST has approved a total of Php 586 Million for our startup development programs. Through the SGF Program, the DOST has supported a total of 58 startups.
 - 2. Technology Business Incubation (TBI) a program that aims to help start up technology-based businesses by providing a range of resources, services, and facilities needed during their development stage. The goal of TBI is to produce firms that will leave the incubation program financially viable and able to sustain operation and compete in the market. Through the DOST's 49 TBIs, we have successfully incubated a total of 1,644 startups. The startups in the TBIs and our SGF grantees have collectively generated 8,077 jobs, received a total of P2B in private investments, and generated a total of P1.3B worth of revenues.
 - 3. Balik Scientist Program (BSP) a DOST program institutionalized through the enactment of Republic Act No. 11035 (Balik Scientist Act) in 2018, where Filipino scientists and experts are encouraged to return to the country and share their expertise to promote scientific, agro-industrial, and economic development, including the development of our human capital in science, technology, and innovation (STI). Since the inception of the program in

1975, riearly 700 scientists have returned to the Philippines, and from July 2022 to June 2023 alone, 44 scientists came back under the program.

- 4. Onelab a network of laboratories aimed at ensuring availability and broadening public access to testing and calibration services at a single touchpoint through an IT based platform. It facilitates the seamless laboratory transaction from sample receipt to release of test result as facilitated by the Onelab Referral System. Currently, the Onelab network comprises 16 DOST Regional Standard and Testing Laboratories (RSTLs), 6 DOST Research and Development Institute (RDI) laboratories, 4 government agencies laboratories, 19 private local laboratories, and 8 international laboratories.
- 5. **OneSTore** an E-commerce Web Application that operates nationwide and caters primarily to Philippine consumers. It helps DOST-assisted MSMEs widen the scope of their target market and provides customers with an effortless shopping experience and retails with simple and direct access to the largest customer base in the Philippines.
- 6. OneExpert a network of (science and technology) S&T experts, intended to improve access to experts and technologies particularly by people living outside of the major urban centers, to bring the services of any accredited expert located anywhere in the Philippines to clients that need S&T assistance.
- 7. Small Enterprise Technology Upgrading Program (SETUP) - a nationwide strategy to encourage and assist micro, small, and medium enterprises (MSMEs) to adopt technological innovations to improve their operations and thus, boost their productivity and competitiveness. SETUP provides MSMEs with equipment and technical assistance to enable them to increase sales and production, streamline and improve overall company operations, upgrade the quality of products and services, conform to national and international standards, and be competitive in their respective fields.
- 8. Community Empowerment thru Science and Technology (CEST) Program - deploys a package of S&T interventions that aims to build progressive and empowered communities. It seeks to assist the "disadvantaged sectors" in the country. The program's implementation entails provision and transfer of technologybased livelihood projects to the identified communities. It facilitates the transfer of technologies to beneficiaries along the areas of education, health and nutrition, water and sanitation, disaster risk reduction, and industry development or livelihood.

(TECHNICOM) Program - aims to fast-track the accessible multimillion pre-commercialization grant and linkage to DOST- Technology Application and Promotion Institute's technology and innovation support programs.

The DOST is also now reformatting and recalibrating its grants-in-aid (GIA) program to require proponents such as our state universities and colleges (SUCs), private higher education institutions (HEIs), and RDIs to include in-depth analysis of potential markets, users/customers, and adopters, market competitors, trends and forecasts in customer needs as well as analysis of the requirements of market and regulatory systems. These analyses are \checkmark expected to include information on export gaps, export requirements, deficits/gaps in the value and supply chains. By focusing on needs of markets and customers, business, and industry, the DOST believes that the country's R&D can be much more solutions-oriented and designed to plug in the observable deficits in these environments.

What initiatives are in place to foster a thriving innovation ecosystem in the Philippines, and how can European businesses actively participate in it?

To foster a thriving innovation ecosystem in the country, Republic Act No. 11293 or the Philippine Innovation Act was enacted into law. It gives priority "to generate and scale up actions in all levels and areas of education, training, research, and development towards promoting innovation and internationalization activities of micro, small and medium enterprises as drivers of sustainable and inclusive growth."

The Philippine government, through the DOST also implements programs and projects aimed at improving the innovation ecosystem in the country, which include programs on R&D, technology transfer and commercialization, startup, those that address the different gaps in commercializing the outputs of R&D, such as assistance in applying for IP protection, strengthening the capacity of partner institutions on technology transfer, as well as technopreneurship. Aside from the testing and laboratory services provided to firms, DOST also established STI facilities, so firms may be able to transcend barriers in trading and compete globally. The TBIs in 55 universities and colleges throughout the country are a platform for inculcating a culture of partnership and learning, value of working in multidisciplinary teams, communication, negotiation, and enterprise-building.

DOST is also currently pursuing the establishment of Knowledge, Innovation, Science, and Technology {KIST} Ecozones, a new type of ecozone that will help strengthen the collaboration among the government, academe, and industries to accelerate R&D, facilitate currently extending scholar ships to talented and deserving the commercialization of outputs, and support/nurture innovative startups and spin-offs among other initiatives PhD degrees in science and engineering in reputable

> European businesses can actively participate in the innovation ecosystem in the Philippines by:

- Forming partnerships and collaborations with local companies and institution. This may involve sharing of expertise, knowledge, and resources to support innovation and R&D initiatives in the country.
- Exploring investment opportunities in the Philippines' innovation sector, such as funding startups or establishing R&D centers. By investing in the local innovation ecosystem, European companies not only contribute to the growth and development of the sector but also gain access to a pool of talented individuals and innovative ideas.
- Participating in knowledge exchange programs and capacity-building initiatives. This may involve providing training and mentorship programs for local entrepreneurs and researchers, as well as facilitating technology transfer and sharing best practices.
- Participating in relevant conferences, exhibitions, and trade fairs (like the National Science and Technology Week) in the Philippines to showcase their innovative products and services. This can help create awareness and visibility for European companies while also fostering collaboration opportunities with local stakeholders.
- Seizing the opportunity to partner and operate with startups and spin-off companies in special ecozones or engage in any activities enumerated in the Strategic Investment Priority Plan (SIPP) to enjoy fiscal incentives. Aside from capacity building and the TBIs, the KIST Ecozones may also be a good platform for collaboration with EU companies.

What collaborative projects or initiatives are the Philippines engaging in with European countries to drive innovation and technology advancements?

The DOST has existing agreements with France, Italy, Hungary, and the UK through various modes of cooperation such as capacity building, joint research projects, and research mobility initiatives, among others.

DOST is collaborating with France on research mobility projects through the Philippine-French Hubert Curien Partnership (PHC) "Science for the People" (PHC-SFTP). The program aims to support the scientific mobility of researchers and facilitate the establishment of joint research projects. In addition, UK, France and Italy are Filipino students/researchers to study and obtain MS and

foreign institutions. This will help the Philippines develop a pool of high-quality human resources in science and engineering who will contribute to the country's global competitiveness and economic development.

Philippines partners with the UK's Royal Academy of Engineering for the Leaders in Innovation Fellowship (LIF) where they provide engineering and technology innovators with access to experienced UK mentors, an international network of peers, and high-quality skills training focused on commercialization and maximizing their technology's impact on society. From 2014 to 2020, the DOST supported a total of 90 Filipino cohorts. Later this year, DOST participated in the LIF Global 2024. Selection of Filipino innovators is currently ongoing; where Philippines is expected to host an in-country event for the selected fellows in February 2024.

The country is also working with the National Copernicus Capacity Support Action Program for the Philippines (CopPhil), the EU's earth observation flagship programme, which provides free environment and climate data derived from a constellation of satellites -the Sentinels which monitor the earth and its many ecosystems 24-hours daily. This free information aims to help public authorities, businesses, and international organizations mitigate climate change impacts and build a sustainable future for all. In the Philippines, Copernicus' satellite images have already helped authorities monitor the situation of remote communities in the aftermath of typhoons such as Odette or accidents like an oil spill to help authorities plan their disaster preparedness and mitigation plans and response. The Copernicus programme for the Philippines is a pioneer initiative in the Asia Pacific and a starting point for a larger programme on Digital Connectivity. The programme will enhance capacities for a stronger and more shock-resilient Filipino economy and society, as well as support reciprocal exchanges between the Philippines and the EU. This 10-million Euro programme, which will run for three (3) years, is in line with DOST's commitment under the Philippines and EU Partnership and Cooperation Agreement which includes cooperation on science and technology, disaster risk management, and climate change adaptation and mitigation.

What incentives or grants are available to promote research and development activities, and how can European companies access these opportunities?

Delivery Act of 2018. It is being implemented by the Anti-Red Tape Authority (ARTA) which is also mandated to implement various reform initiatives to combat red tape and ensure that the various government units and agencies comply thereto. RA 11032 aims to streamline the current systems and procedures of government of specialized and scientific equipment essential for services. Amongst its purpose is to lessen the turn around time to be followed and to efficiently guide the public in conducting their respective interests in all types of Philippine soil. For DOST, it is a sound legal basis for streamlining the procedures for the granting of scholarships, certifications, and sponsorships and approving the submitted proposals related to research and development for the benefit of Filipinos.

One other specific regulatory hurdle that the DOST is working to address is the simplification and streamlining of the process for obtaining permits and licenses related to research and development activities. To overcome this challenge, DOST is collaborating with relevant government agencies to develop more efficient and streamlined processes, reducing unnecessary red tape, and promoting a business-friendly environment.

Another regulatory barrier that the DOST is focused on is the protection of intellectual property rights. The government is actively working to strengthen the legal framework for intellectual property protection, ensuring that innovators and businesses can confidently protect and monetize their intellectual assets. This includes providing education and support to researchers and businesses on intellectual property rights and facilitating the registration and enforcement of these rights.

DOST is also working towards the development of comprehensive data protection regulations that comply with international standards, safeguarding the rights and 2. interests of individuals and businesses.

DOST is actively engaged in Congressional Hearing in amending the Government Procurement Law. It was able to lobby in the Substitute Bill the inclusion of P100,000.00 cap in direct procurement of goods and services subject to accounting rules and regulations for practical and easier purchasing of goods and services without the need for public bidding. Direct acquisition is added as another mode of procurement in Sec. 74 of the Substitute Bill.

In developing the Implementing Rules and Regulations (IRR) of Sec. 71 of the Substitute Bill, particularly "Item F. Scientific, Scholarly or Artistic Work, Exclusive Technology and Media Services", DOST will lobby for the inclusion of

Goods 'Not Commonly Used Supplies and Equipment (CSE)' as part of the eligible items of procurement. DOST aims for refinement of procurement guidelines for research and development in science and technology. There is a need for explicit guidelines in procurement cutting-edge research. Absence of clear guidelines on the matter can lead to prolonged deliberations or even legal guandaries hindering progress of vital research projects. This will expedite the procurement process by eliminating ambiguities and empower research institutions to acquire state of the arts tools crucial in groundbreaking scientific work.

To further resolve concerns in procurement, DOST is in the planning stage of developing its own S&T procurement manual through a Procurement Summit. This will be attended by S&T Expert and Procurement Officers of DOST Attached Agencies and Regional Offices. This will fast track and specifically address the needs and barriers in procurement of S&T equipment and research and development supplies and materials. In coordination with Government Procurement Policy Board (GPPB), the S&T procurement manual will enable an agile and responsive procurement process designed for specific needs of research and development. It will also include best practices and standard which will serve as a blueprint to operationalize nuanced provisions of the previous law.
