Interview with the Ambassador of the Delegation of the European Union to the Republic of the Philippines

How has the EU's approach to diplomatic relations with the Philippines evolved over the years, particularly in light of changing global dynamics?

Bilateral relations between the EU and the Philippines started with a focus on development assistance. However, throughout the years, bilateral relations extended to other areas, culminating with the entry into force of a comprehensive EU-Philippines Framework Agreement on Partnership and Cooperation, covering key areas of mutual interest including, but not limited to, combatting terrorism and transnational crimes, cooperation on human rights, justice and peace, countering proliferation of weapons of mass destruction, trade, migration and maritime labour, employment, disaster risk management and health. In an international context marked by conflict and aggression, the European Union and the Philippines stand together in the defense of multilateralism and of international law.

In the footsteps of the Green Economy Global Gateway program, the EU has started to work with our Philippine counterparts on a Digital Connectivity Global Gateway program. The P3.62-billion grant Green Economy Program will empower the national government, LGUs and the private sector to lead the way in sustainable green practice, promoting a circular economy, waste reduction and expansion of energy efficiency and renewable energy. From EU Member States we expect about P9 billion of grant investments linked to this Program, plus P12 billion in sovereign loans and more in private sector investments. This will support the Philippine transition to a circular economy, reduce plastic waste and boost renewable energy production.

The Philippines' wealth in critical green metals such as nickel, copper, and cobalt positions it as a key player in sustainable technologies, crucial for manufacturing batteries for electric vehicles and other green technologies. This resource abundance offers significant investment opportunities for European stakeholders interested in eco-friendly solutions.

In addition to the FTA, the DTI supports transformative legislation and policy changes to foster a conducive business environment for foreign investments. Key measures include the Corporate Recovery and Tax Incentives for Enterprises (CREATE) Law, which provides incentives for strategic investments, and the Retail Trade Liberalization Act, which lowers capital requirements for foreign retail investors. Other significant reforms are the liberalization of the Renewable Energy sector and amendments to the Public Services Act, allowing full foreign ownership in crucial sectors.

Furthermore, the DTI promotes trade facilitation measures that streamline regulatory procedures and reduce trading costs. Executive Order Nos. 18 and No. 32 have also been implemented to establish green lanes for strategic investments and simplify permitting processes for telecommunications and internet infrastructure, enhancing the overall ease of doing business between the Philippines and Europe.

What are the DTI's aspirations in line with the recent announcement on the resumption of EU-PH Free Trade

The DTI aims to leverage the FTA to modernize the Philippine economy and deepen economic partnerships with Europe. The focus extends beyond enhancing trade and investment flows to include building long-term, strategic collaborations that contribute to economic resilience and innovation.

The group also raised several questions from the private sector, including the concerns on Customs Memorandum Order No. 12-2021 and Customs Administrative Order No. 01-2020, among others. Co-chaired by Atty. Mark Tamayo and Mr. Michael Raeuber, the meeting was also joined by representatives from the ECCP Customs and Logistics, Tax and Financial Services, and Food and Beverage Committees.

FDA Center for Food Regulation and Research (CFRR) Kapihan Sessio 15 April 2024

On April 15, ECCP attended the FDA Kapihan session to discuss various topics, including the allowable exhaustion period, ticketing system updates (suspended since 1 March), and e-portal enhancements such as the migration of food product registration to FDA eServices targeted for deployment by 28 May 2024. The Joint Foreign Chambers Urge Senate to Approve Critical Airport Refor

The Joint Foreign Chambers (JFC), in a letter to the Philippine Senate, called for the approval of crucial legislative measures aimed at overhauling the governance framework f the country's airports. Specifically, the JFC emphasized the importance of (1) the Civil Aviation Authority Act of the Philippines (CAAP) Law amendments to strengthen CAAP's role in safety oversight by enhancing human resource development, fortifying

the board, and aligning with global safety standards, (2) the creation of the Philipping Airports Authority to separate the conflicting functions of the CAAP as an airport regulator and operator, and (3) the creation of the Philippine Transportation Safety Board to strengthen the government's ability to investigate accidents and improve safety. The letter also comes after numerous flights in and out of the Ninoy Aquino International Airport (NAIA) on Monday were delayed due to a technical issue with the navigational air traffic management system

The letter reads, in part, "These reforms are essential to enhancing the safety, efficient and overall quality of both domestic and international airports in the Philippines.

The letter also notes that these legislative reforms were also recommended in Senate Committee Report 39, filed on March 23, 2023, following the legislative inquiry into the air traffic management system glitch at Ninoy Aquino International Airport, and calls for the appropriate structure in place to prevent similar transport incidents from happening in the future

The JFC is a coalition of the American, Australian-New Zealand, Canadian, European, Japanese, and Korean chambers and PAMURI. We represent over 3,000 member companies engaged in over US \$100 billion worth of trade and some US \$30 billion worth of investments in the Philippines. The JFC supports and promotes open inte trade, increased foreign investment, and improved conditions for business to benefit both the Philippines and the countries we represent.
