THE NETHERLANDS TRADE AND INDUSTRY

The Netherlands, despite being geographically small, is a key center within the global business network. Its core distribution points include Rotterdam and Amsterdam Schiphol Airport. The Netherlands is the seventeenth largest economy in the world and the fifth largest in the Eurozone, with a GDP of just under \$1 trillion in 2022. It has capitalized on its location and advanced economy to become one of the top trading nations in the world, being the sixth largest exporter and the eighth largest importer in the world. Its largest foreign investor with the largest trade surplus in the country is the United States. Its economy is considered to be one of the most competitive around the world, with its outstanding performance in areas conducive to innovation and sustainable prosperity.

The top exports of the country include refined petroleum, broadcasting equipment, machinery having individual functions, packaged medicaments, and crude petroleum, which are mostly transported across its neighboring states, such as Germany, Belgium, France, UK, and Italy. On the other hand, its imports include crude petroleum, refined petroleum, petroleum gas, broadcasting equipment, and computers, which are mostly from Germany, China, US, Belgium, and UK. Despite the economic stagnation of the country in 2023, inflation has come down substantially while wages increased, which supported private consumption in going forward.

Geographical Location: The Netherlands is a low-lying country situated in the delta of three major European rivers Rhine, IJssel and Meuse, with around 24% of the land below sea level and only about half of the land exceeds one meter above sea level.

Climate: The Netherlands' climate is considered temperate, with its winter temperature reaching about 3°C and summer temperatures reaching around 17°C.

Official Language: Dutch

Government Type: The Kingdom of the Netherlands is a parliamentary constitutional monarchy. The prime minister is the head of the government and the monarch is the head of the state while the council of ministers holds the executive power.

Standard of Living: The Netherlands outperforms the average in jobs, work-life balance, education, environmental quality, social networks, civic engagement, safety and life satisfaction. The average household net-adjusted disposable income per capita is USD34 984 a year, more than the OECD average of USD 30 490 a year.

Financial District

The Dutch financial sector is well-positioned in Europe with the Dutch Finance Ministry working actively to further boost the position of the Netherlands as a world financial center. One of the most important financial districts of the Netherlands is the Zuidas, also known as the "Financial Mile". It is a rapidly developing business district in Amsterdam with its favorable location relative to the historical city center and a large-scale concentration of business service providers. It is home to a large number of businesses offering financial, legal, and business services.

TOP 3 TOURISM DESTINATIONS



AMSTERDAM

Amsterdam is one of the most-visited cities in Europe, and is considered as one of the world's most bike-friendly destinations. It has roughly 400 km of bike paths and is still adding more. Similarly, the city is renowned for its many world-class museums and galleries like Anne Frank House, Van Gogh museum, and Rijkmuseum. Aside from the popular museums, it is also home to lots of less-crowded attractions like Museum Van Loon—a preserved 17th century canal house that offers a very intimate experience with its homey atmosphere, historic rooms, and gardens of the house.



THE HAGUE

The Hague is often referred to as the "Den Haag" by the locals. Aside from being the seat of the Dutch government, it is also the international city of Peace and Justice, home to many international organizations, including the International Court of Justice, the International Criminal Court and the Permanent Court of Arbitration. The Hague includes an artistic and bohemian neighborhood worth exploring. One of the most popular destinations in the Hague is the Binnenhof and Ridderzaal, which is a historic complex of buildings that houses the Dutch Parliament.



INTERESTING FACTS

- "Netherlands" means the lowlands and refers to the geographic features of the land being both flat and down river from higher areas. It is known as the Kingdom of the Netherlands but its local long form is Koninkrijk der Nederlanden.
- The Netherlands is the first country to legalize same-sex marriage in December 2000 when the Dutch parliament passed, by a three-to-one margin, a landmark bill allowing the practice. The legislation gave the same-sex couples the right to marry, divorce and adopt children.
- The Netherlands is the largest producer of tulip bulbs in the world, providing 4.2 billion annually and exporting half. Every year, seven million flower bulbs are planted in Keukenhof Garden in the Netherlands. When the springtime arrives, it sprouts to produce beautiful rows of reds, oranges, and yellow, including other varieties of tulips.
- With over a thousand historic windmills operating in Holland, the Netherlands is called "the land of the windmills". The first windmill in the country was built in the 13th century and then in the 17th century, the industry of Dutch windmills had experienced advanced development.



ROTTERDAM

Rotterdam is the economic capital of the Netherlands, being also the largest port in Europe, at the mouth of the Rhine river with excellent rail, road and river connections to the heart of Europe, especially Germany. It is also a popular tourist destination due to its daring and modern architecture like the cube houses, which are tipped to one side, making three sides face the ground and three face the sky. Aside from this, tourists enjoy visiting the floating farm-a micro-dairy moored in the port of Rotterdam wherein people can buy dairy products, watch milking cows, and see the milk and yogurt processing.

Interview with the Ambassador of the Embassy of the Kingdom of the Netherlands to the Republic of the Philippines

Since first arriving in the Philippines to take up your post as Dutch Ambassador, what have been your observations on the relations between the Netherlands and the **Philippines?**



The Netherlands and the Philippines have many common interests and shared values.

We are both seafaring nations for example, and vulnerable We have over 150 active Dutch companies established in for climate change. We collaborate in several sectors such as the Philippines. With the increasing effects of climate change, and therefore more typhoons and floods in the Philippines, a highly relevant area for cooperation. Our water-sector is working on various projects here. For example, we are working with several local governments and Dutch companies on flood protection with the use of 'nature based solutions'. Quite innovative, more effective and cheaper than just using concrete walls.

We also consistently rank as a large foreign direct investor (FDI) in the Philippines. What do you find is the Philippines' greatest strength that would serve it best when doing business with Europe?

I would say that the Philippines still has so much potential for further growth. As a place to do business, and also for an expat to live, the Philippines has much to offer. Of course, the young labour force, the English proficiency and the open mindedness of the Filipino people make life easy. Filipinos are eager to learn, are adaptive and want to move forward.

For us as a European country, it is also important that the government is opening up the economy, by new legislation, introducing 'fast lanes' and promoting more efficiency through e-portals and digitalization. We have high hopes for the upcoming FTA between the EU and the Philippines, and I am confident that the Netherlands and the Philippines can further benefit from that.

Having said this, I also believe there is still some catching up to do compared to neighboring countries in the region, especially in terms of 'ease of doing business'. I would encourage the government to further continue to get rid of the 'red tape' and simplify procedures for foreign investors; that seems to be the major issues Dutch companies sometimes face.

What efforts have been put in place to expand Dutch companies across the Philippines? Which sectors are Dutch businesses most active in?

danger of the 'middle income trap'. Lessons learned show that a focus on investment, on improving the regulatory and institutional frameworks and on innovation are essential to achieve long term growth.

The Netherlands and Europe are natural partners for the Philippines in this process. Our society and our private sector have a strong focus on sustainability and innovation - that is how we achieved our prosperity, being now one of the most advanced economies in the world. I envisage that there will be more Filipino companies that partner with Dutch enterprises for sustainable and innovative products and solutions, having an overall positive impact on society.

In addition to the Ambassador's interview. ECCP requested information about the Dutch government's initiatives, the Embassy's Economic Section and the Ministry of Economic Affairs and Climate provided responses about the Embassy's national policy.

What measures is the Dutch government taking to increase investments in research and development, and how does this align with the state's goals for sustainable growth?

We believe it is important for the Netherlands to keep up with the rapid pace of global technological developments. The Netherlands also believes it is important to think smartly about how the government can create the right conditions to encourage other public and private parties to invest. We have developed a National Technology Strategy in partnership with industry, civic organizations and knowledge institutions that could encourage and give space for innovative companies to grow, prosper and be internationally competitive.

What are the key priorities of Dutch national innovation strategy, and how does it align with international trends and best practices?

The Netherlands is good at developing new technology: our researchers and industry are at the forefront of developments in machine building, computer chips, agrifood technology, biotech and medicines.

For example, with the aim of The Netherlands being a global leader in the development and manufacture of next generation systems by 2035, we will focus on strengthening or attaining a position of technological leadership in priority technologies. We however recognize that these technologies would only be successful if they are used to have a positive impact on our society, so technologies must be designed for a real, complex context and must take account of the behavior of people and/or must fit into industrial ecosystems.

Therefore, we look at the challenges our community is facing, like climate change, energy shortage or an aging society. These challenges form the need for smart solutions, and it is our mission to support the innovators through the whole ecosystem, from the student with a smart idea, to the start-ups to the growth into a future company like ASML.



In what way is the Dutch collaborating with other countries to foster innovation, and how does this international cooperation enhance the Dutch innovation ecosystem?

The Netherlands cannot lead the way in all technologies (we are too small for that). We must continue to collaborate with our partners in Europe and beyond, preferably with likeminded countries that share our standards and values.

The Netherlands' leading technological position helps to bolster the international position of the EU as a whole. This serves the interests of both the Netherlands and Europe: European and international collaboration is essential to acquire a strong position in the technologies of the future. This will ultimately improve our international competitiveness, national security and allow us to make better use of technology to tackle the challenges we face as a society.

How does the Netherlands leverage societal challenges to drive innovation, and can you provide examples of successful initiatives that have emerged from this approach?

The Smart Cities strategy was introduced in 2017 by several large and smaller cities in the Netherlands. The strategy aims to improve the quality of life in Dutch cities, such as Amsterdam to foster innovative solutions, and enhance international competitiveness. This initiative serves in bringing together innovation professionals from government, civil society, businesses, and research institutions and focuses on shaping the future by addressing various themes such as energy, mobility, and the circular economy.

How does the Dutch government support small and medium-sized enterprises (SMEs) in adopting new technologies, particularly in the context of digital transformation and industry?

We recognize that special attention should be given to the challenges faced by startups, scaleups and innovative SMEs as they can be the foundation for the Netherlands' future earning potential.

However as technology development is capital and R&D intensive as well as high-risk, The Netherlands also needs to identify technological niches, or combinations thereof, where we can excel. These niches stem from our knowledge position, our infrastructure, including digital infrastructure, and public-private partnerships. We also depend on our services sector, legislation and regulations and international relations to help us acquire high-value positions in value chains.

How is the Netherlands positioning itself as a digital frontrunner, and what initiatives are in place to support the digital transformation of businesses, particularly small enterprises?

The Netherlands is in a good position to host a biomolecular and cell technologies ecosystem that can be amongst the best in the world. However it is essential that a state-of-theart public-private research infrastructure is available for both fundamental and applied research to support startups and SMEs that often have limited access to existing facilities due to the high costs.

The Netherlands is presently studying the opportunities to open research and test facilities for the three areas of application, namely: health, biochemical and agrifood industries that would enable multiple research disciplines and stakeholders to work together in these accessible and shared research test facilities.

What do you see as the main challenges facing the Dutch innovation system in the coming years, and how is the government planning to address these challenges?

The Netherlands is particularly concerned about geopolitical tensions. Not all players play the game fairly. In addition, if a single country acquires a leading position in a particular technology, we may become disproportionately dependent on a single party for that technology. That may make us vulnerable, for example if we lose access to that technology.

This particularly applies to technologies of great strategic importance, such as computer chips and artificial intelligence. If we wish the Netherlands and Europe to remain relevant, we must invest in strategic technologies, human resources, facilities and support the companies that develop them.

How does the Dutch government support smart cities and the startup ecosystem to promote innovation and the development of digital skills?

In 2017, the Netherlands rolled-out its National Smart City Strategy to improve the quality of life in Dutch cities and to introduce innovative solutions to increase their international competitive strength, which was participated in by the country's largest five cities (Amsterdam, Rotterdam, The Hague, Utrecht and Eindhoven) together with the G32 of middle to large size Dutch towns.

These Dutch towns and cities agreed that investments in smart technology are necessary to respond to major social challenges, such as expanding pressure on public amenities and infrastructure, urbanization, climate change, employment, digitization and mobility.

Together, the public and private parties as well as the academic institutes innovative solutions were introduced to improve the digitalization of Dutch cities. Among which include mobility and accessibility of cities, sustainable and low-energy homes and building, improvements of air guality

In support of promoting technology and innovation, the Dutch Government established a National Technology Strategy that provides building blocks that identifies key enabling technologies where Dutch knowledge and industry can make a positive impact and where the Netherlands can develop a unique position. Additionally, the Kabataang Digital campaign delivers of-its-kind systems and mechanisms for compliance, such child-friendly educational content, fostering digital literacy as the DBNMS and NPCRS. and responsible online behavior among youth.

Through these measures, the NPC reinforces public trust in digital governance by ensuring that as digital services grow, and privacy and security remain top priorities.

How is the Philippine government investing in digital The NPC regularly issues advisories and circulars that provide guidelines for protecting the personal data of data subjects. One of which is the NPC Circular 2023-06, which outlines security requirements for personal data processing in both government and private sectors. It mandates PICs and PIPs to designate and register a DPO, register data processing systems, conduct Privacy Impact Assessments (PIA), implement a Privacy Management Program, provide regular privacy training, and comply with NPC issuances. The Circular also establishes guidelines on data storage, requiring personal data to be retained only as necessary and protected using industry standards. Additionally, it enforces strict access control measures, detailing authentication protocols, authorized personnel procedures, and remote data security mechanisms.

What are the major digital transformation initiatives currently being implemented by the NPC, and how does it impact local communities?

The NPC also serves as the first fee-funded secretariat the NPC will also strengthen its awareness campaigns of the Global Privacy Assembly (GPA), which provides leadership at the international level in data privacy and protection. The NPC also became a member of the Global Cooperation Arrangement for Privacy Enforcement (Global CAPE), a multilateral arrangement for Privacy Enforcement Authorities (PEAs) to collaborate and cooperate in crossborder data protection and privacy enforcement.

Furthermore, the NPC will host the 2025 Global Cross-Border Privacy Rules (CBPR) Workshop bringing together government officials, regulators, and privacy experts from over 20 jurisdictions to enhance interoperability between different data privacy regimes.

What emerging technologies is the NPC focusing on to drive innovation, and how does it plan to foster an ecosystem that supports startups and tech entrepreneurs?

The NPC issued NPC Advisory No. 2024-04 on the guidelines on the application of DPA and its IRR, and NPC's issuances to artificial intelligence systems processing personal data. It outlines the obligations of PICs and PIPs, mandating transparency, accountability, and privacy risk assessments for AI developers, and ensuring that data subject rights will be upheld.

Also, the NPC entered into an agreement with Aboitiz Data Innovation (ADI) to promote the development, adoption, experimentation, and testing of innovative privacyenhancing technologies (PETs) upon use cases on sandbox environments. It also seeks to provide and share insights on its effectiveness, benefits, and future challenges in the field of data privacy and protection. The insights and learnings gained from this collaboration will then guide the NPC in crafting future regulatory requirements, standards, policies, guidelines, and best practices regarding PETs.

What role do public-private partnerships play in advancing the NPC's goals for innovation and technology?

The Commission recognizes the importance of publicprivate collaborations in driving data privacy awareness and compliance. In addition to its partnership with Aboitiz Data Innovation (ADI), the NPC signed a Memorandum of Agreement (MOA) with GCash, a mobile wallet and digital payments platform, allowing it to integrate the Commission's educational materials within the GCash application to promote privacy awareness among its users. The platform will also feature a direct link to the NPC's Registration Portal, encouraging businesses to comply with data protection regulations.

These collaborations with the private sector help amplify data privacy awareness and enhance regulatory compliance, which fosters a more secure digital environment.

What are the targeted measures of the NPC to help sustain the growth trajectory of the Philippines' digital economy?

The NPC will continue to issue and enforce policies that align with emerging technologies, ensuring data protection keeps pace with technological advancements. Likewise,

to equip Filipinos with the knowledge and skills needed to protect their personal data in an increasingly digital environment. By offering guidance on compliance with the law, enhancing digital literacy, and ensuring cross-border data transfer mechanisms are in place, the NPC supports a trust-based digital economy that encourages investments and innovation.

Additionally, the NPC is working with data privacy stakeholders to develop sector-specific privacy frameworks that cater to financial technology (fintech), e-commerce, and artificial intelligence, which will ensure that data-driven industries remain competitive while protecting data subject rights.

How is the government emphasizing the development of digital skills to maintain the country's skilled workforce in lieu of the advancement of Artificial Intelligence?

The government is promoting digital upskilling to ensure that Filipino workers remain competitive in the global digital landscape, and equipped with the skills needed to thrive in an increasingly automated world. Our mother agency, the DICT, offers Strengthening the Philippine workforce through the Adaptive and Responsive Digital Knowledge (SPARK) Program, which aims to strengthen the Philippine workforce by enhancing people's capacities to secure employment in ICT-related fields.

Complementing these efforts, the NPC also integrates data privacy education into digital upskilling initiatives. Recognizing that AI and automation rely heavily on personal data, the NPC ensures that digital literacy programs also emphasize responsible data handling, cybersecurity, and privacy protection. These include a dedicated episode of Privacy in the Spotlight focusing on Artificial Intelligence and its impact on data privacy. Additionally, NPC conducts training programs such as DPA Briefings, which equip DPOs and the general public with a fundamental understanding of the DPA and its application in various professional settings. Hence, the NPC ensures that Filipino professionals are both adept in emerging technologies and knowledgeable in data privacy protection and compliance.

The NPC emphasizes the importance of digital skills, data privacy awareness, and an empowered citizenry in strengthening the culture of privacy. More importantly, we aim to improve the quality of data privacy education in the Philippines. With that in mind, we issued NPC Circular No. 2023-02 or the Data Privacy Competency Program. The Program will be composed of courses on the fundamental and operational aspects of the DPA which are essential for anyone who seeks to have a better understanding of the law and its application to actual situations, and other projects.

ECCP side meetings on EU-PH FTA 13-14 February 2025

Following our meeting with Chief Negotiator, Ms. Dora Correia, the ECCP also held separate meetings from 13-14 February at the ECCP Office and via Zoom to cover specific chapters of the proposed EU-PH FTA particularly on Digital Trade, Automotive, and Customs.

On 13 February, FTA Digital Trade Chapter Negotiator Ms. Monica Cunningham met with representatives from the ECCP ICT-BPM-KPM Committee at the ECCP Office in Makati City to discuss potential barriers and identify key areas to foster an enabling environment for digital trade. The meeting highlighted sector-specific concerns namely, (1) customs duties on electronic transmissions, (2) data localization and cross-border data flows, and (3) disclosures and accessibility to source code.
