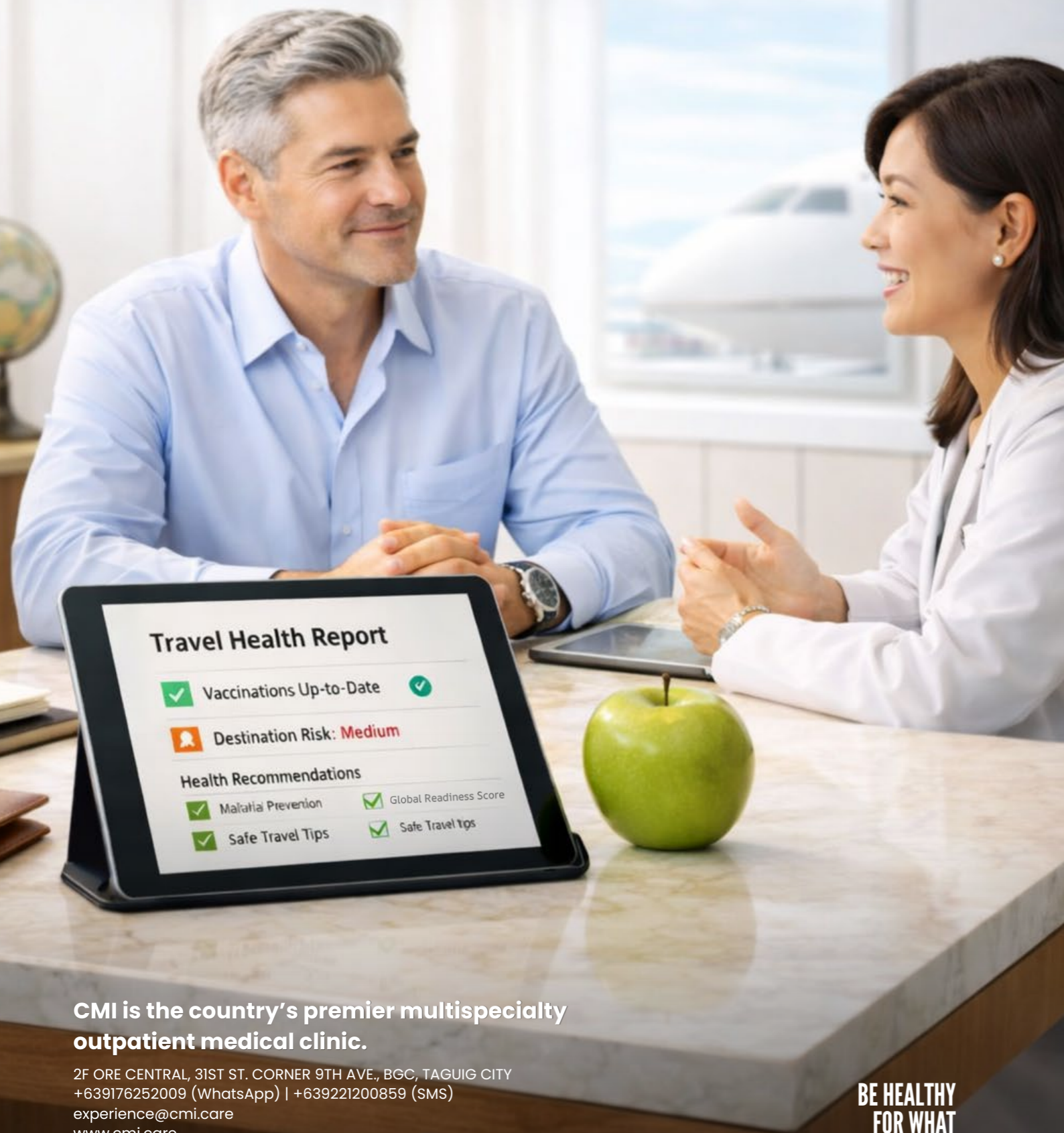

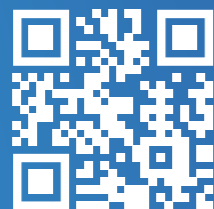

Interview with the Tourism Infrastructure and Enterprise
Zone Authority Chief Operating Officer

Hon. Mark T. Lapid



TIEZA has emphasized a community-first approach to tourism development. How does the agency operationalize its commitment to inclusive and sustainable tourism in project selection, funding allocation, and stakeholder engagement?

At TIEZA, we believe that travel must enrich the destination and not just the traveler. Every Filipino peso that is collected from the travel tax is a reinvestment to where it should rightfully belong, which is our communities. They are the bread and butter of our destinations. We give preference to projects that bring about real change which is generating jobs in local communities, promoting small holder enterprise and protecting the exceptional culture and natural beauty of the Philippines. By partnering with local governments and communities, we allow our infrastructure projects to not just get bricks and mortar moving, but people as well and hence, sustainable development needs to reach the poor, where they are.

Which key objectives of the National Tourism Development Plan are currently the focus of TIEZA's initiatives, and how are these being measured for impact?

TIEZA's initiatives support the National Tourism Development Plan's priorities on tourism infrastructure, accessibility, connectivity, destination development, and equalization of tourism opportunities. Through Tourist Rest Areas (TRAs), Tourism Enterprise Zones (TEZs), destination infrastructure, and investment promotion, we improve visitor experience and destination readiness. Impact is measured through increased accessibility, tourism investments, employment generation, visitor satisfaction, and the expansion of tourism opportunities in emerging destinations.

Metro Manila has one of the lowest green space ratios per capita in Southeast Asia. How does TIEZA assess the current green space gap? How does the Agency integrate the development of accessible green public spaces into tourism planning?

We recognize the need for more accessible green spaces in Metro Manila and view heritage parks and recreational open spaces as important tourism assets. The Rizal Park Complex, which TIEZA designated as a Flagship Tourism Enterprise Zone, exemplifies this approach. TIEZA classifies green space not as a secondary aesthetic amenity, but as a vital national tourism asset and a prerequisite for urban livability. As density increases, the

institutionalization of urban "lungs" has become a non-negotiable pillar of our national tourism strategy. We also support initiatives such as the rehabilitation of Burnham Park in Baguio City. Across our projects, we integrate landscaped open spaces, climate-responsive features, pedestrian-friendly areas, and environmentally sensitive design to improve public well-being and destination resilience.

In the context of climate change and natural disasters, how does TIEZA ensure that its infrastructure projects are resilient and adaptable?

Climate-risk reduction is integrated into the planning, design, and implementation of TIEZA projects. We invest in wastewater management systems, drainage improvements, environmental monitoring, and renewable energy initiatives. Heritage preservation efforts, including the 3D laser scanning of UNESCO-listed Baroque Churches, help safeguard cultural assets. Tourist Rest Areas also serve as resilient community infrastructure and have been used as relief and donation hubs during emergencies.

The Philippines is known for its unparalleled beauty but it now also needs future-proofing initiatives. The climate is changing and we are changing with it. From installing eco-friendly systems in coastal towns to digitally mapping our centuries-old Baroque churches to preserve their legacy, our infrastructure is built to weather the storm.

Climate-risk reduction is integrated into the planning, design, and implementation of TIEZA projects. The most obvious manifestation of that is our Tourist Rest Areas. On any regular day, they are a traveler's paradise but when nature flexes her muscles, these resilient, well-stocked facilities quickly become lifesavers and sanctuaries for the local population.

In PBMM's 2025 SONA, he emphasized the tourism sector as a tool for job generation. How is TIEZA aligning its projects to capitalize on this potential and contribute to national employment goals?

Every time a new tourism site opens, a community transforms. We see tourism infrastructure as the ultimate catalyst for Filipino talent and hard work. Every time TIEZA develops a destination, investments follow which helps inject new vibrancy into the local economies. A beach, newly accessible to the public, not only draws tourism but guests to a regional inn, diners to a restaurant and buyers to the loom of cooperative weavers. We are very proud to be constructing the facilities that help Filipinos build back a better life, with our trademark Filipino hospitality becoming the engine for building the nation from employment and education.

When developing lesser-known destinations, how does TIEZA address challenges like limited accessibility, infrastructure gaps, and local capacity support tourism?

The best travel stories often begin where the paved roads end. But to sustainably share our lesser-known islands and mountains with the world, a destination must be ready. TIEZA is the intermediary between seclusion and potential. We create the essential eco-facilities, restrooms and visitor centers that allow for comfortable travel off-the-beaten-path. Utilizing planning thoughtfully, we work with benign towns so that by the time the prism of our collective gaze finally permeates their unsullied beauty, its homes are well prepared to flourish in stewardship of their own stuff.

With the recent DOT-DTI MOU integrating One Town, One Product (OTOP) offerings into TRAs and the Philippine Experience Program, how is TIEZA facilitating market access and support for MSMEs in tourism destinations?

A road trip through the Philippines is a journey through its culture, one town at a time. We have transformed our modern Tourist Rest Areas into living galleries of local heritage. Now, when you pause your journey, you aren't just grabbing a coffee; you are stepping into a vibrant marketplace featuring the best One Town, One Product (OTOP) program. By giving local weavers, bakers, and craftsmen a dedicated space to shine, we are ensuring that travelers can take a piece of the province home, while directly putting money into the hands of the community.

KLM offers free WiFi on European flights

KLM is one of the first European airlines to offer free internet to passengers traveling within Europe, marking an important step in enhancing the travel experience. Throughout their flight, passengers can email, browse the internet, listen to music, play games, or stream movies and TV series. With this initiative, KLM is fulfilling a frequently requested feature by its customers. Starting January 22, passengers can take advantage of the free WiFi service.

KLM is rolling out free WiFi in phases across most of the aircraft used for its European routes. Half of the European fleet will be equipped with free internet service as of Thursday. In the coming years, WiFi will be available on all A321neo, Embraer 195-E2, and a portion of the B737-800 aircraft.

KLM's European fleet does not feature in-seat entertainment screens. By offering complimentary internet, KLM aims to enhance passenger comfort. After logging

in or registering as a Flying Blue member, passengers can enjoy unlimited internet access during their flight. Stephanie Putzeist, responsible for customer experience at KLM, commented: "We listen carefully to what our passengers value and free internet has been on their wish list for some time. Through this step, we are making travel within Europe more personal and comfortable: everyone can plan their flight in their own way and stay connected. We are delighted to realize this now for our passengers."

A more pleasant travel experience

Since August last year, KLM has added 12 new A321neo aircraft to its fleet. These aircraft, which serve European destinations exclusively, are equipped not only with WiFi but also with modern, comfortable seats. In this way, KLM aims to ensure the most enjoyable travel experience possible for its passengers.

ECCP Names Diana Edralin as President, Welcomes New Board of Directors

Makati City, Philippines — On 26 May 2026, the European Chamber of Commerce of the Philippines (ECCP) named its new President and welcomed two new members to its Board of Directors during its Annual General Membership (AGM) Meeting and Sunset Socials held at the Marquis Events Place in Bonifacio Global City, Taguig City.

Dr. Diana Edralin, currently the General Manager of Roche Philippines, was elected President of ECCP. She brings extensive experience in healthcare with her and is the first female and Filipina president of the Chamber. The election marks a leadership transition, with ECCP President Edralin succeeding Paulo Duarte.

Elected as ECCP officers were Dr. Diana Edralin, President; Mr. Lars Wittig, Mr. Ruben Camba, and Mr. Roman Menz as Vice Presidents; and Mr. Albert Perez as Treasurer.

Judge Cesar Cruz will continue serving as ECCP Corporate Secretary, joined by Atty. Peter Calimag and Mr. Gerry Constantino, as Assistant Corporate Secretaries.

The new Board will steer the Chamber's strategic direction from 2026 to 2027 and further strengthen its commitment to advancing trade, investment, and economic ties between Europe and the Philippines. Made up of leaders from diverse industries, the

Board brings extensive expertise to support ECCP's advocacy and inclusive growth initiatives.

During the AGM, members of the Chamber also reviewed key accomplishments over the past year, discussed future priorities, and reaffirmed ECCP's commitment to promoting a competitive and sustainable business environment in the Philippines.

At the Chamber's Sunset Socials, outgoing ECCP President Paulo Duarte was likewise recognized for his three years of leadership, during which the Chamber strengthened its advocacy work and expanded engagement across key industry sectors. Among the notable achievements under his term were the ECCP's deeper collaboration with both public and private sector stakeholders to advance European-Philippine business relations and the ECCP's highest membership count since its founding in 1978 - reaching close to 1,000 members.

Advocacy Corner

CIPE-AMCHAM Roundtable Discussion

25 March 2026

The Center for International Private Enterprise (CIPE), in partnership with the American Chamber of Commerce of the Philippines (AmCham) and its Advocacy Department, Arangkada, hosted the roundtable discussion, "Enhancing the U.S.-Philippine Economic Security Alliance through Policy Innovation," on 25 March at the AmCham Office in Makati City.

This gathering marked the launch of two publications developed by both organizations, namely, "Policy Options for Enhancing U.S.-Philippines Economic Security Alliance" and the "Private-Sector Advocacy Framework for the U.S.-Philippines Economic Security Alliance." These documents highlight policy and regulatory challenges, as well as opportunities to strengthen trade resilience, investment cooperation, and defense industrial collaboration.



In attendance were several members from the Joint Foreign Chambers of the Philippines (JFC), alongside relevant industry associations and private sector representatives. Representing ECCP at this event were Industry and Government Affairs Co-managers Austin Sy and Joaquin Reloj.

From Kyiv to Manila: Opportunities in Agri-Food Trade

25 March 2026

On 25 March, The Makati Business Club and the Embassy of Ukraine to the Philippines, with the support of the European Chamber of Commerce of the Philippines, organized a closed-door roundtable discussion in conjunction with the official visit of the State Service of Ukraine on Food Safety and Consumer Protection (SSUFSCP) delegation.

The session focused on providing Philippine business leaders in the agriculture, meat, and logistics sectors with a direct overview of Ukraine's agricultural products while also exploring potential pathways for bilateral trade, market access, and private sector partnerships in the dairy, poultry, and pork industries.

Mr. Serhii Tkachuk, Head of the State Service of Ukraine on Food Safety and Consumer Protection, delivered the keynote presentation during the



discussion. He is a senior Ukrainian government official specializing in food safety regulation, agri-trade policy, consumer protection, and sanitary and phytosanitary administration. Representing the Chamber was Mr. Julius Barcelona, Chairperson of the ECCP Agriculture Sub-committee on High-Value Crops, who delivered the welcome remarks.

Powering The Next Phase of Energy Storage: Grid-Forming Batteries in a High-Demand Power System

14 April 2026

On 14 April, Fluence Energy (Philippines), together with the European Chamber of Commerce of the Philippines, organized the event “Powering The Next Phase of Energy Storage” at the Makati Shangri-La. ECCP Online Information Session - Responding to the Oil and Energy Situation with DOE: Guidance for the Private Sector

Ms. dela Cruz also provided a clear outline of the government’s contingency measures and policy directions, alongside practical guidance for businesses on energy conservation, risk mitigation, and operational planning.

Moderating the subsequent fireside chat and Q&A session was Atty. Jose “Jay” Layug, Jr., Senior Partner at DivinaLaw and Co-Chairperson of the ECCP Renewable Energy & Energy Efficiency Committee.



Senate Committee on Migrant Workers Technical Working Group Meeting

20 April 2026

On 20 April, the ECCP Human Capital Committee participated in the Senate Committee on Migrant Workers’ Technical Working Group on the proposed Bagong Balikbayan Act. The proposed legislation aims to create a comprehensive, integrated and sustainable reintegration program for returning OFWs.

The bills focus on consolidating the necessary entrepreneurship support, skills recognition and development, and social protection programs among various national agencies in order to facilitate balikbayans’ effective transition back into the country following their overseas employment. The Committee supported and emphasized conducting the design, implementation, and evaluation of reintegration programs in consultation with business chambers and groups in the private sector.

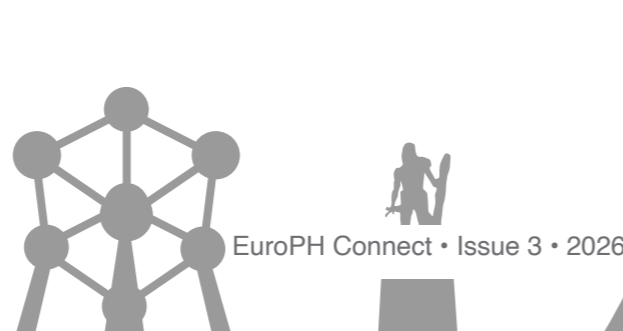
Science2Business: Energy Resilience for Enhanced Security

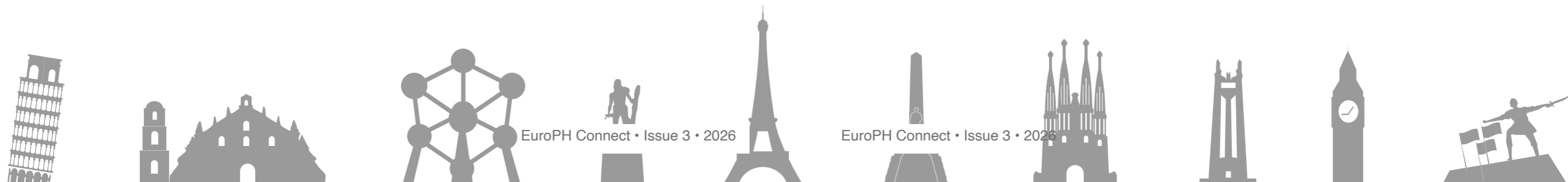


ECCP Sustainability Committee Meeting with GRI 29 April 2026

The ECCP remains committed to working with government partners to create a more efficient, transparent, and business-friendly environment for European companies and their employees operating in the Philippines.

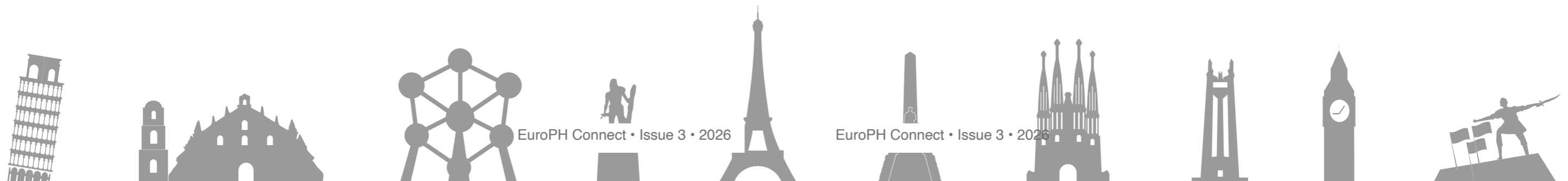


FIRB Virtual Town Hall Meeting on the DILG–DOF–DTI JMC No. 1, s. 2026

ASEAN-EU Sustainability Summit 2026

7 May 2026

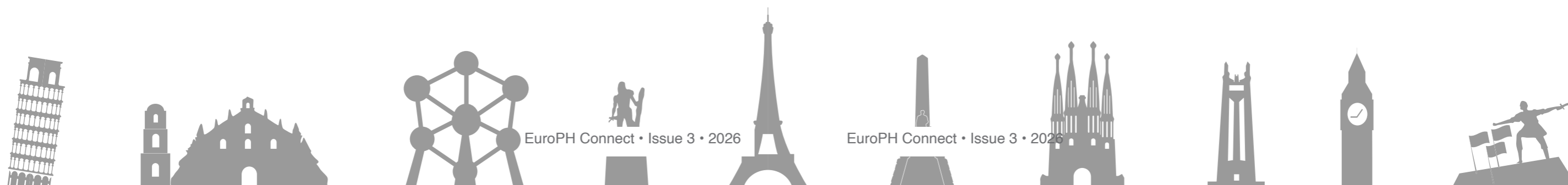
Europe Day 2026

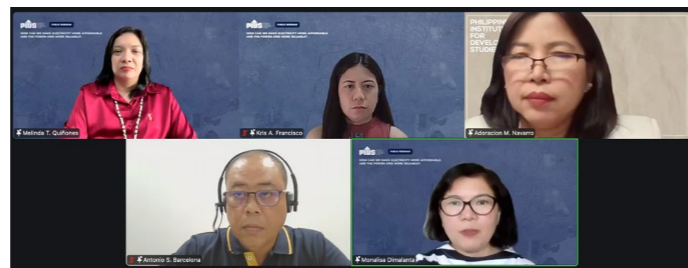


Philippine Institute for Development Studies (PIDS) Webinar

14 May 2026

On 14 May, the Philippine Institute for Development Studies (PIDS) hosted a public webinar via Zoom examining critical challenges in the country's energy sector. Titled "How can we make electricity more affordable and the power grid more reliable?," the webinar highlighted two recent studies providing a comprehensive discussion of how pricing policies and infrastructure reforms can work together to improve energy outcomes in the Philippines.

The first study, "Making Electricity Subsidies Work: Cross-Country Lessons for Philippine Energy Policy," authored by PIDS Senior Research Fellow Dr. Kris A. Francisco and PIDS Research Analyst Patricia Thea A. Basilio, analyzes the country's major subsidy mechanisms and draws on international evidence to assess their effectiveness.



Complementing this, the second study "The Need for Power Transmission Sector Reforms in the Philippines," by PIDS Senior Research Fellow Dr. Adoracion M. Navarro, examines structural and regulatory constraints in the transmission sector amid rapidly rising electricity demand.

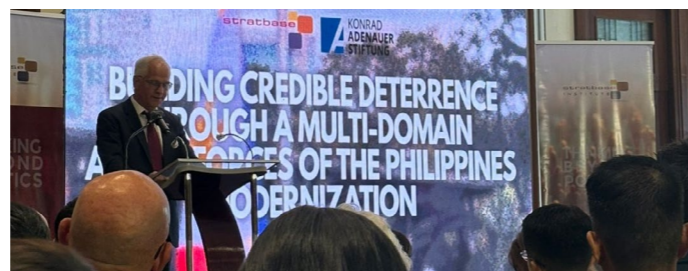
Former Energy Regulatory Commission Chairperson and PJS Law Office Senior Partner Atty. Monalisa Dimalanta along with Department of Energy Officer-in-Charge of the Power Market Development Division Mr. Antonio Barcelona joined the webinar as discussants to provide further insights and expand on the comprehensive studies presented.

Building Credible Deterrence Through a Multi-Domain Armed Forces of the Philippines Modernization

14 May 2026

On 14 May, the Stratbase Institute, in partnership with the Konrad-Adenauer-Stiftung (KAS) Philippines, convened a forum at the Manila Polo Club, Makati City, titled "Building Credible Deterrence Through a Multi-Domain Armed Forces of the Philippines Modernization." The forum gathered representatives from government, the military, academe, the private sector, and the diplomatic community to examine how the Armed Forces of the Philippines (AFP) can transform into a multi-domain force capable of deterring both traditional and asymmetric threats, with the year marking the 10th anniversary of the Arbitral Award on the South China Sea and the Free and Open Indo-Pacific (FOIP) vision.

Stratbase Institute President Prof. Victor Andres "Dindo" Manhit opened the forum by citing recent survey data showing that 65% of Filipinos support the modernization of the AFP and the Philippine Coast Guard, while 51% favor reinforcing alliances through joint patrols and military exercises. H.E. Dr. Andreas Michael Pfaffernoschke, Ambassador of the Federal Republic of Germany to Manila, delivered the keynote



message, noting that the current global security landscape echoes the Cold War era and underscoring Germany's renewed focus on deterrence, expanded defense capacity, and continued cooperation with the Philippines built on ties dating back to the 1970s.

The first panel examined the gaps, challenges, and opportunities in the AFP modernization program. Panelists discussed the trade-offs between acquiring brand-new versus second-hand assets, the balance between quantity and quality in defense procurement, and the constraints posed by limited and restricted modernization funds. The second panel turned to advancing the AFP's transformation into a truly multi-domain force across the land, maritime, air, and cyber domains. Panelists emphasized the shift from a service-centric to a state-centric defense posture, with interoperability at the center of modernization efforts.

Updates on the Bureau of Customs Priorities

14 May 2026

On 14 May, the European Chamber of Commerce of the Philippines (ECCP) participated in an insightful dialogue with Bureau of Customs (BOC) Commissioner Ariel F. Nepomuceno. Hosted by the American Chamber of Commerce of the Philippines at the SGV Office in Makati City, the forum provided key insights into the critical reforms, modernization efforts, and policy directions currently shaping the country's trade and customs environment.

During the discussion, Commissioner Nepomuceno outlined the agency's transition toward full digitalization. These initiatives aim to eliminate manual interventions, integrate financial data verification, and deploy Artificial Intelligence to significantly curb smuggling and corruption. The BOC reaffirmed its sincere commitment to collaborating with the private sector.



Representing the ECCP at the dialogue was Industry and Government Affairs Manager Austin Sy. The ECCP remains dedicated to engaging in these pivotal dialogues to support a transparent, predictable, and highly efficient business environment for our members.

DTI Trade Policy Dialogue (TPD)

14 May 2026

On 14 May 2026, the ECCP participated in the 10th Trade Policy Dialogue with DTI Undersecretary Allan B. Gepty. The session provided a critical roadmap for the Philippine trade landscape and the much-anticipated EU-PH Free Trade Agreement (FTA). With the goal of concluding negotiations by the end of 2026, the DTI is pushing for a comprehensive agreement covering 24 chapters, including green energy, e-commerce, and the first-ever inclusion of government procurement.

The dialogue hosted discussions on fostering an open and predictable business environment while respecting constitutional frameworks, with the Philippines adopting a "negative-list" approach for services and investment. This strategy prioritizes clarity and stability for international partners, notably by streamlining dispute resolution through established domestic legal channels. Beyond expanding market opportunities, the dialogue emphasized the importance of aligning local practices with international sustainability and environmental standards.



Undersecretary Gepty also highlighted the government's commitment to balancing global intellectual property protections with the preservation of local traditional knowledge and community rights. These initiatives are designed to build on recent legislative reforms—such as the Public Service Act and the CREATE MORE Act—further positioning the Philippines as a premier destination for high-value European investment.

IOPHIL 6th Review and Assessment of the MOU on E-Commerce

19 May 2026

On 19 May, the ECCP Intellectual Property Rights Committee attended the 6th Review and Assessment of the Memorandum of Understanding on E-Commerce (“Philippine E-Commerce Code of Conduct”) in Taguig City, hosted by the Intellectual Property Office of the Philippines.

The review was an opportunity to evaluate and analyze the initiative’s progress, discuss solutions to recurring and new challenges and strengthen cooperation in addressing online counterfeiting and piracy. Updates on BIR Tax Priorities

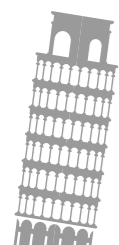
20 May 2026

On 20 May, the European Chamber of Commerce of the Philippines (ECCP) participated in an insightful briefing featuring Bureau of Internal Revenue (BIR) Commissioner Mendoza. Held to discuss the Bureau’s strategic progress and priorities, the dialogue provided key updates on critical tax reforms, modernization milestones, and the ongoing implementation of the agency’s nationwide “DARES” program aimed at enhancing tax administration and service excellence.

During the discussion, Commissioner Mendoza highlighted the BIR’s priorities through its DARES agenda as well as reforms such as the operationalization of a more predictable and accountable audit framework under RMO 1-2026, limiting assessments to just one Letter of Authority (LOA) per taxpayer per year. Backed by accelerated digitalization efforts, the BIR successfully exceeded its January-to-April collection targets. The Commissioner also addressed critical private sector concerns during the open forum

JFC Monthly Meeting hosted by AmCham

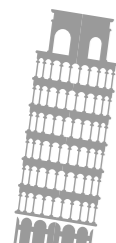
Continuing these important discussions, the ECCP will also host its second Transportation Forum on 10 September 2026 with the theme "Driving

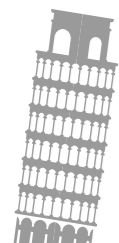

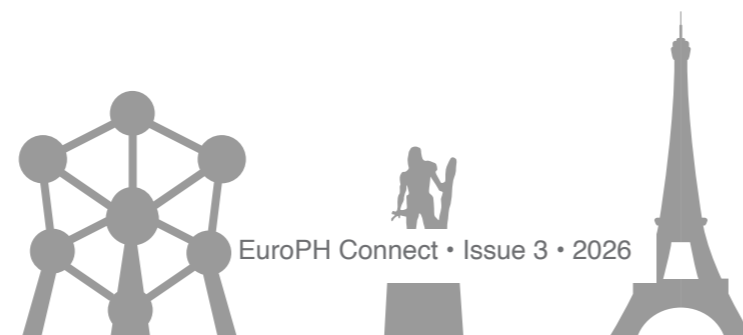

He also highlighted the agency's early progress in 2026, including the rollout of digital tools aimed to improve taxpayer experience: system-assisted audit selection framework, LOA Verifier, Interactive Digital Tax Calendar, QR Code Verifier for Certificates of Registration, and the Revenue Monitoring and Intelligence Dashboard (ReMIND).

"Excellent service worthy of your taxes is not just a campaign line—it is what the Bureau must now prove through actual work: better systems, clearer rules, and reforms that taxpayers can feel," Mendoza stated.

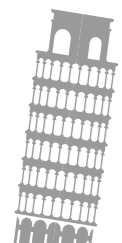
ECCP Courtesy Visit to the Embassy of the Republic of Poland in the Philippines

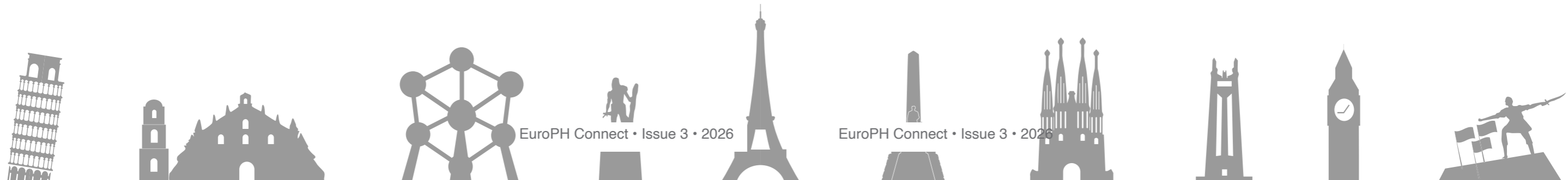

Villanueva, Misamis Oriental — Building on the momentum of its annual council assembly, the European Chamber of Commerce of the Philippines (ECCP) Northern Mindanao conducted a high-level site visit and industry consultation on 13 May within the PHIVIDEC Industrial Estate-Misamis Oriental (PIEMO). 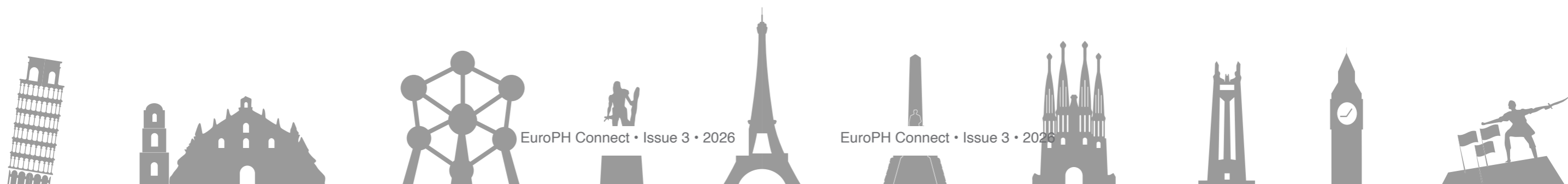

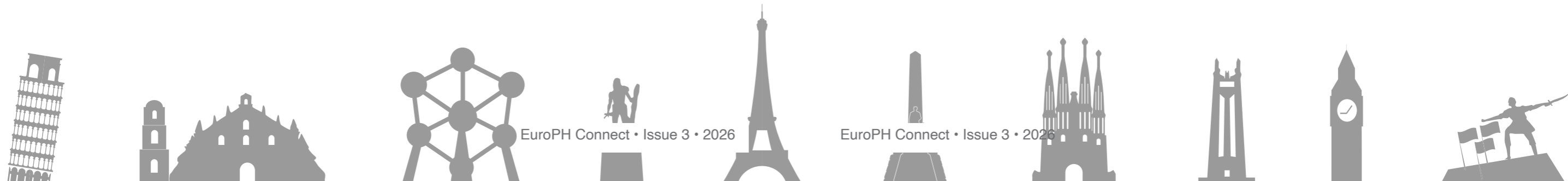
ECCP Davao Visits Hijo Banana Plantation with Norwegian Delegation 29 April 2026
