### DANISH TRADE AND INDUSTRY

Denmark is a vital member of the European Union, and it has been a nation of traders ever since the Iron Ages. Today the GDP comes from roughly 75% service sector, with the industrial sector proceeding it with around 19.1% contribution. 60% of the country's land is dedicated to agriculture, resulting to production of twice the food needed by its inhabitants. Other sectors that contribute significantly to the economy are the energy, pharmaceutical, biotechnology, maritime, design and innovation sectors.

# Jan Top Christensen of Denmark

Reflections on his experiences from his five years of service in the Philippines, and some thoughts about the future development of the country Since first arriving in the Philippines to take up your post as the Danish Ambassador, how have you observed the relations between Denmark and the Philippines develop and progress? The Danish export to the Philippines between 2013 and 2018 has increased by 125%. I am happy to say that at the same time the Philippine export to Denmark has also gone up. Export of goods here and in Copenhagen as well. It is a very useful framework to discuss issues among friends in the interest of both sides.

It is very clear that the Philippines, in general, is benefitting from the EU GSP+, the special preference scheme offered by the EU in 2015. The EU GSP+ has helped a lot in increasing the Philippine exports to the EU because all of these goods can now be exported without any tariff, and that is obviously also positively affecting the export to Denmark.

In spite of the fact that I have no official budget for cultural activities, we have been able to raise funds through Danish foundations, the Ministry of Culture in Denmark and with the cooperation of authorities here. The National Commission for Culture and Arts has been very instrumental in facilitating Danish artists coming here. We are also working closely with the film council, FDCP, headed by the dynamic chair-woman, Liza Diño, in spreading the news about Danish films. There is a cultural organization in Denmark called P-NOiSE comprised of second-generation Filipinos and others, who have organized events featuring Philippine culture in Denmark and Danish art in the Philippines. We've also had Danish opera singers, and youth choirs come here. We have established some recurrent events, such as the Annual Danish Film Festival. The fifth version will be in October.

We support the Duterte Government's view that we should decentralize our activities. We're trying to branch out geographically for both cultural and business activities. I've been on a number of business trips to Davao and Cebu trying to make Danish companies aware of the great opportunities in provincial cities. Our film festival has so far also taken place in Davao, Ilollo, Cebu and Baguio. - These are some of the things that have happened since I took office here five years ago.

#### It's really interesting that you mentioned that it's not always just about business and trade, it's also about cultural exchanges.

Yes, we have often seen that they can support each other and we were able to create sponsorships from Danish companies. These companies see that increasing the profile of Denmark and creating a positive interest in the country will also increase the interest in their products. We also have five to ten Danish NGOs linked with local NGOs that work in different areas such as humanitarian, environmental, fisheries and other fields.

## What do you find is the Philippines' greatest strength that would serve it best when doing business with Europe? What about with its ASEAN neighbors?

agreements with Singapore, and specially Vietnam, I would expect it to be easier with a market economy such as the Philippines. And Vietnam has death penalty. Philippines has not - for the time being. I hope that the negotiations can be accelerated. It should be noted that the GSP+ will not be there for eternity. I think that when the Philippines moves up into a higher income category, they will not have this offer from the EU. Therefore, we must look into something that will replace the GSP+ . Right now, they should continue using it efficiently, and then both sides can come together and agree on accelerating negotiations on the FTA.

One of the future strengths of the Philippines could be the country's agriculture and agua produce. I think that refinement of the produce, moving the products up the value chain in country, should take place because the more you can move up the value chain, the higher the value of the products you can sell in the European market. There is a potential to do more here in the Philippines, refining, packaging and storytelling, so the final product being sent out of the Philippines would result in the creation of more jobs locally. In general, it looks as if agriculture has been left behind. This is the sector where you find huge poverty. Massive investment and modernization are needed.

I am impressed by the Philippine furniture industry, design and good craftsman-ship, and I see a potential for increased export in this area. The Philippines is also a seafaring nation, but I've been wondering, and have not gotten a real explanation, as to why the country does not have a stronger national commercial fleet that could play a role in the world market. Therefore, modernization of the fleet and special attention to energy efficiency of the ships must be looked into. Denmark has expertise in this area and is ready to help-out.

#### What do Danish businesses find most attractive about doing business with the Philippines? How do you think the Philippines can continue to be an attractive environment for Danish companies to do business?

There are several reasons why the Philippines is an attractive market and location for Danish companies. The first key asset is that there are no language barriers. When I talk to Danish businessmen, they always mention that the country has a big pool of talent coming from universities, it is also the mentality and servicemindedness of the Filipinos that Danish companies appreciate. Thus, it is important that the English language skills are treasured in the universities. Imagine if Spanish had been your number one foreign language. No BPO-sector!

We also have many new companies showing interest in the Philippines across sectors. Duterte's impressive "Build, Build, Build" program has attracted the attention of a number of Danish companies such as engineering consultancy firms that can help in designing and refining plans for these big projects and make sure they become correctly executed. One company is already involved in building the third bridge between Cebu and Mactan. Two years ago, a Danish architect company won the competition for the new BCDA HQ building. These are concrete and good examples of Danish companies having the potential to be part of this huge infrastructure development.

The economic progress in this country was one of the main reasons why we decided to come back. We saw potential for Danish companies to be involved. The Duterte-government is continuing with high growth rates and I'm very optimistic that this will continue for the next three years. The latest upgrading by Standard & Poor's to a BBB+ is a very positive indicator. The Philippine government has a very professional economic team, Danish companies are impressed with their high level of competence, and initiatives. The law on "Ease of Doing Business" is very much welcomed. It is important that this process continues and I know that this government is very ambitious to move higher up on the World Bank rankings when it comes to ease of doing business. Creating a sound and healthy level playing field without discrimination of

foreign companies is key for attracting more foreign investment.

The fight against corruption is also very important. We all know that corruption makes economic transactions less efficient because it does not produce the best solutions. I still talk to Danish businessmen and I have examples of how they are affected by the corruption in the government system. The government's keenness in fighting corruption is very welcome. The recent initiative with ARTA has already proven its value by solving a long pending problem for a Danish company. It bodes well for the future.

Thus, with very high growth rates, the initiatives of fighting corruption, and the ease of doing business, there is a very positive framework for coming here. It is also important that these developments should not only happen in Metro Manila, but also be extended to the provinces and at the local level.

#### What do you envision as the future business and trade between Denmark and the Philippines, and how do you think both partners can work better together to achieve this vision? And if I may add as well, how does the Royal Danish Embassy in Manila specifically help foster a positive business environment between Denmark and the Philippines?

As I've said, the main reason for the reopening of the Embassy was to be able to assist Danish companies in engaging with Philippine authorities and business. We are heavily involved in trying to open doors for Danish companies, give guidance on how to read the situation, and to highlight the new initiatives by the government so Danish companies will be aware of these opportunities. I would take departure in the new (since June) Danish government's initiatives and policies. They're extremely interesting and they become the framework for the way the Danish economy will move forward the coming years and will also affect the way Danish companies do business.

In the fight against climate change, the new Danish government has set the ambition to become the international leader in the green transition. One of the targets agreed upon by the political party in government and those three parties supporting it, is to lower by 70% greenhouse gas emissions by 2030 in comparison to 1990. This is a very ambitious goal and has also been questioned as to whether it is feasible. The government recognizes that for the last 5 percentage points from 65% to 70%, they don't have a specific plan for that as of now, because this is something all experts and political authorities must work together to achieve. Since we find ourselves in a climate crisis, it seems to be necessary to be able to fully live up to the targets of the Paris Agreement from 2015, if we don't want to face the serious consequences of drastic climate change. The Paris Agreement and the goals are key for the Danish government, who is set to seriously analyze what has to be done actively to reach them.

There will have to be a transition within the transport sector. One sub-target is that you will not be allowed to sell new fossil fuel cars in Denmark by 2030. This is one way of moving forward. There will also be very ambitious steps taken within the agricultural sectorsince both the transportation sector and the agricultural sector are major culprits when it comes to greenhouse gases.

Denmark is already a heavyweight when it comes to research to find more efficient solutions to increase energy efficiency and so forth. More money will be put into research to find smarter solutions. This will put pressure on the Danish companies within a number of sectors, but it will also create new solutions which will be made available for export. Through this, we will be the leading country when it comes to reaching the Paris targets. At the same time we will make a transition in such a way that we'll also be a very green partner in the future in engaging with countries including the Philippines.

At the end of the day, this shopping mall would net produce energy by using all kinds of modern technology- not just In terms of economic conditions, it is very important that there is a level playing field so the conditions that Danish and foreign companies meet here are the same as those of the Philippine companies. I see a great interest from the present government to increase foreign direct investment because it's still at a relatively low level compared to the ASEAN region. Foreign direct investments can come up to a much higher level if the right conditions exist. However, there also has to be a clear framework for other conditions within which the foreign companies will set up business. If there is uncertainty, people will stay away and wait until this is clarified. The Trabaho Bill is important and I hope very much that Congress will understand that and push through with it because it is a key framework for setting up business here. To invite more foreign companies to set up business and increase foreign direct investments, there should be ease of doing business here. In comparison to the Philippines, Vietnam has much more direct foreign investment, although it's a smaller country. That's a good example that there is potential out there that would create many more quality jobs, and I see that the economic secretaries are very keen on that. It's also a question of whether the Congress sees and understands that and moves forward. If we have these reforms within the next three years, I think there's potential for the Philippine economy to move up beyond 7% growth target of gross domestic product for the years to come. With the potential there, it is a matter of the right reforms and also that people, including Congressmen, understand that protecting local interests sometimes may be in the interest of some local businessmen, but it's for sure not in the interest of the Filipino people.

solar panels on the roof, but also using technologies available that drastically reduce energy consumption. Given the fact that the current energy costs of the mall is 60% of the costs, if this can be reduced, you can greatly reduce your costs to the benefit of the owner of the shopping mall, which will also affect prices. This is a concrete example of what I see for the future of Danish companies engaging with local companies. There is no doubt that this new Danish government's high ambitions on reaching the Paris climate change targets will frame the way we project Danish companies here in the Philippines. This should be seen in the larger context of the 17 sustainable development goals (SDGs). It's something we have already started. Through the Nordic Chamber, we have had meetings with local partners. We'd possibly start with big companies which have resources so that they see the benefits of applying the 17 sustainable development goals as a framework for inspiration on how they can rationalize all the processes within their companies and change the way things are produced. The challenge and ambition is to include smaller companies. As we typically do in Denmark, this would be done through some government assistance where the government chips in with resources to assist the small and medium sized companies in availing new technologies. Another area where we have been engaged and will do much

more in the future is the smart city concept. For example, we have engaged with New Clark City under BCDA and are actively in the process of planning a new delegation coming later this year to engage with them and the companies involved in building the New Clark City. Danish companies have a lot of experience when it comes to energy efficiency, waste management, and other aspects of smart cities. In relation to this, Copenhagen, our capital, is hosting the secretariat for this international cooperation called C40. C stands for cities wherein only 40 were initially involved but now there are 96 cities worldwide. These are cities that have come a long way, when it comes to modern technology to create smart

cities and using these to reduce the negative aspects of grouping people together. There will be a summit on the 12th to the 13th of October in Copenhagen for which we have facilitated the invitation of top management from BCDA and Quezon City, which has come very far. Quezon City is now linked to this C40 concept. We see potential for more Philippine cities to be involved. I myself have had preliminary talks with people from Davao. We know that the mayor of Davao is very environment-oriented, so I would like to see Davao become part of this forum for the exchange of smart city solutions in the future.

In our vision, what will frame the thrust of our activities will be the ambitions of our new government to be the leading green nation, and being inspired by the 17 SGDs.

### Is there anything else you'd like to add, Ambassador?

There are many other things I could mention such as the environmental issues you have in this country. President Duterte made a necessary decision to rehabilitate Boracay, and it opened doors for Danish technology. The "Boracay model", as I would call it, may be the clean-up model for other tourist destinations and operating in accordance with regulations, so that you don't end up with a cesspool. In this situation, Danish companies came in with proven technologies because for decades, we have had strict rules and regulations on how we deal with our environment. If we don't take this seriously and enforce the rules, we will drown in dirt and garbage.

This interview was conducted last July 2019 while Mr. Jan Top Christensen was still the Ambassador of the Kingdom of Denmark to the Philippines. Mr. Christensen has officially ended his five-year term as Ambassador last September 2019 and was succeeded by Her Excellency Ambassador Grete Sillasen.

### Understanding some key areas of AgTech

There is a significant array of AgTech solutions in the market for farmers to choose from, such that the choice can be overwhelming. To help farmers sort the wheat from understanding data on a pest's activity, location and patterns the chaff KPMG, in partnership with several organizations (Food Agility CRC, IAG, AgriFutures, MLA, NFF and others), is developing an AgTech Finder Platform (www.agtechfinder. com) to assist farmers to find the right AgTech solution for their requirements. Some of the AgTech use cases available to Australian farmers include:

### Farm management platforms

Utilizing production data collected off the farm through IoT sensors, farm management platforms offer a congregated dashboard of information for farmers. The dashboard allows farmers to manage and optimize the production activities and operations of their farms. As well as monitoring variables such as soil quality, weather variables and fertilization, there is also an ability to track livestock.

### **Smart irrigation**

The use and management of water on farms is in the spotlight. Approximately 70 percent of the total volume of water withdrawals in the world is used in agriculture irrigation. Around 60 percent of the water that is intended for irrigation is lost, either due to evapotranspiration, land runoff, or inefficient usage methods.

Smart irrigation solutions offer an IoT fueled management platform that can closely monitor and adjust a farm's water utilization. A dashboard that integrates irrigation information means farmers have access to tools that enhance decision making around water. This means they can reduce water wastage and improve the quality of crop growth in their fields through precision agriculture practice. Factors such as timing, being able to minimize wastage and runoff, and analyzing soil moisture levels give power to farmers to fine tune their irrigation requirements. Implementing smart irrigation also reduces the chance of human error, with automated systems such as smart valves alleviating this.

### Weather & climate monitoring

Climate, rainfall and extreme weather conditions create further uncertainty for farmers in an already volatile environment. Technology to monitor external factors, such as weather predictions, puts the farmer back in the driver's seat to manage their farm with more certainty. For example, picking a crop a day early could offset the wipe-out of an entire crop if they know a storm is coming.

The ability to precisely manipulate inputs also enables the farmer to be in better control as to what they put into their farming systems as a management tool. As heat increases, for example, they can adjust their irrigation systems to input more water to offset dry conditions.

### Pest management

Most farms currently monitor pests using visual cues. This is common practice but is performed periodically by qualified pest technicians. This is expensive, labor intensive, not monitored consistently, and lacks the ability to identify and react to an outbreak in real-time.

The ability to remotely monitor pests will assist with the maintenance and health of a farm. Collecting and allows for efficient and sustainable treatment of pests, integrated biosecurity tracking and more rapid responses across affected areas.

Opportunities to better manage pests on farms could be through connection of traps to report specific pest levels, thus automating monitoring and data collection to take more accurate and quicker countermeasures.

The ability to share data on biosecurity with the relevant agency and community enables faster risk mitigation and intervention.

### Imaging, drones and UAVs

Satellite imaging, intelligent drones, and unmanned aerial vehicles (UAVs) can assist farmers to collect images.

Imaging can identify changes to soil and vegetation, identify crop stress, and assess irrigation and assist crop spraying. Farmers can conduct crop forecasting and better manage their agricultural production and inputs.

Integrated mapping from various images can identify issues and therefore improve yields and efficiency of time for farmers. It can also be used as a tool to track livestock, and drones can be used to deliver inputs such as fertilizer.

# Moving Towards Agricultural Development: An Interview with Senator Cynthia Villar



Senator Cynthia Villar at Sustainable Agriculture Forum 2019 held last 24-25 July at the Marriott Grand Ballroom.

Can you tell us what legislations you would propose to introduce, amend, or repeal in the 18<sup>th</sup> Congress to develop the Philippine agriculture sector?

The following are the first few bills I have filed when the Senate of the Philippines opened its First Regular Session for the 18<sup>th</sup> Congress (2019-2022). These are the legislations related to agriculture:

 $\checkmark$  For the Coconut Industry:

• An Act creating the Coconut Farmers and Industry Trust fund, providing for its management and utilization, and for other purposes. My committee has actually passed this on Third Reading during the 17<sup>th</sup> Congress last year, but it was vetoed by President Duterte. So I have re-filed it with some amendments/revisions.

 $\sqrt{}$  Senate Bill 140 or the Free Index-Based Agriculture Insurance Act that seeks to establish the enabling policy, regulatory, and funding support for a more effective crop insurance program and to strengthen the resiliency of small farmers against climate change and extreme weather risks

 $\sqrt{Amendments}$  to the Agri-Agra Law or an act providing for further compliance with section 7 of R.A. No. 10000, otherwise known as the "Agri-Agra Reform Credit Act of 2009" to ensure that enough funds will be channeled to the agriculture sector which has been lagging behind in terms of growth. The original law mandates banks and financial institutions to set aside 25 percent of their loanable funds for agricultural and agrarian reform financing, but there has been reported low compliance.

 $\checkmark$  Senate Bill No. 139 or the Philippine Livestock, Poultry & Dairy Industry Development Act: to restructure and rationalize the livestock industry in order to strengthen its development, protection and regulatory functions, including the promotion of dairy and native animals, and to provide for a livestock development fund, and for other purposes.

 $\checkmark$  An Act to amend the Food and Drug Administration (FDA) Act of 2009 to separate the administration of Food from Drug to make processes such as approvals faster.

√ Senate Bill No. 807 or The Philippine Fiber Industry Development Program of 2019, that seeks to spur the revival and the development, production, processing, marketing and distribution of Philippine local fibers (cotton, piña, ramie, silk, maguey, among others) in suitable areas of the country in order to provide income to people living in rural areas and spur economic growth.

√ Senate Bill No. 2203 under Committee Report No. 625, which amends Republic Act 10068 or the Organic Agriculture Act of 2010 that seeks to institutionalize the Participating Guarantee System or PGS in our country to help small organic farmers attain the organic certification they need to compete in local and global markets at a more affordable cost. PGS offers a complementary and low-cost system of quality assurance, with a heavy emphasis on social control and knowledge-building. PGS, as a complementary method to third-party certification, is essential to the continued growth of organic agriculture in the country. This will encourage poor and small farmers to adopt organic agriculture standards and methods.

 $\checkmark$  Senate Bill No. 147 or the Instructional Gardens Act mandating the establishment of instructional gardens in all elementary and secondary schools, public or private, making it a requirement for the creation and issuance of permits for schools and for other purposes. This bill aims to institutionalize the "Gulayan sa Paaralan" (instructional gardens) program to promote health awareness, good nutrition and help curb malnutrition

### How will the Senate work closely with the executive branch to facilitate government efforts in addressing challenges and harnessing opportunities faced by the sector?

As a legislator, I work closely with the government departments in charge with the three committees I chairthe Senate Committee on Agriculture & Food, Senate Committee on Agrarian Reform, and the Senate Committee on Environment & Natural Resources. And those are the Department of Agriculture (DA), Department of Agrarian Reform (DAR), and the Department of Environment and Natural Resources (DENR). I have a good working relationship

with the new DA Secretary William Dar, DAR Secretary John Castriciones, and DENR Secretary Roy Cimatu. The Senate also has oversight functions, senators do not just legislate; we also have to look into the proper implementation of the laws we author. That entails a lot of coordination with the Executive Branch of the government, particularly the Cabinet Members.

# Q3 farm output growth fastest in 2 years

FARM OUTPUT grew by its fastest clip in more than two years in the third quarter, as increments in most subsectors offset a drop for palay which accounted for 15% of total value of production, the Philippine Statistics Authority (PSA) reported on Wednesday.

The PSA said that value of agricultural output, which contributes about a tenth to gross domestic product and a fourth of the country's jobs, grew 2.87% year-on-year in the third quarter, turning around from contractions of 0.87% a year ago and 1.27% in the second quarter.

It was agriculture's best performance since a 6.2% growth recorded in 2017's second quarter and the best third-quarter performance since the three percent posted in 2016.

Third quarter growth pushed up agriculture's year-to-date performance to 0.77%, compared to the 0.14% increment in 2018's comparable nine months.

That compared to the 2.5-3.5% target range for farm output growth under the 2017-2022 Philippine Development Plan.



"I think it is a very good start for a new administration [at the Agriculture department] and for new policies that affects agriculture sectors, considering that this is third quarter – usually we have the lowest output for rice seasonally," University of the Philippines School of Economics Professor Ramon L. Clarete said in a telephone interview.

Agriculture Secretary William D. Dar said in a statement: "We were expecting between 2-2.5%. This shows that the farmers and the fishers are showing resilient performance with the programs and projects of the DA (Department of Agriculture).

Crops, which accounted for 45.19% of total farm output, grew 2.01% in value last quarter but still slipped 1.64% year-to-date.

Volume of palay output fell 4.53% to 3.051 million metric tons (MMT) in the third quarter and by 4.94% to 11.321 MMT yearto-date, while that of corn production grew 23.47% to 2.723 MMT last quarter and by 5.94% to 6.321 MMT year-to-date.

"Corn was actually quite surprising," Philippine Institute for Development Studies Research Fellow Roehlano M. Briones said when sought for comment, adding that "farmers are moving out of palay, so I think that accounts for the (palay) contraction..."

The PSA attributed the drop in palay production "to the substantial reduction in harvested areas in Western Visayas and SOCCSKSARGEN (South Cotabato-Cotabato-Sultan Kudarat-Sarangani-General Santos City in south-central Mindanao) due to insufficient water supply."

"The same reason was cited for decreases in harvested areas in CALABARZON (Cavite-Laguna-Batangas-Rizal-Quezon), MIMAROPA (Occidental and Oriental Mindoro-Marinduque-Romblon-Palawan), Central Visayas, Eastern Visayas, Zamboanga Peninsula and Caraga," the report added.

The other farm subsectors grew.



Poultry output, which contributed 19.44% to the total, went up 8.41% last quarter and 5.91% year-to-date. Chicken production, which accounted for 14.72% of total farm output, increased by 8.48% last quarter and 5.25% year-to-date.

# **Advocacy Updates**

### **ECCP Aviation Committee Meeting** 04 September 2019

After its agenda-setting meeting, the ECCP Aviation Committee met last 4 September to fine-tune the next steps of the committee and identify its priorities. The Committee hopes to have an audience with a number of decision-makers from various government agencies such as DOTr, CAAP, among others. The Committee also discussed its strategies and priorities for the remaining months of 2019.



### Meeting with Bureau of Plant Industry on Fall Armyworm | 06 September 2019

The ECCP met with the Bureau of Plant Industry (BPI) to exchange views on the government's pest management efforts to prevent the entry of the fall armyworm in the country. The ECCP encouraged the BPI to work closely with the private sector, especially through the ECCP Agriculture Committee, to boost its pest control strategies. Last May 2019, BPI issued a memorandum instructing agriculture officials across the country to conduct detection surveys to determine the presence of the destructive pest.



### Public Consultation on the Implementing Rules and Regulations of the Energy Efficiency and Conservation Act | 16 September 2019

The ECCP was represented at the Department of Energy's public consultation on the Implementing Rules and Regulations (IRR) of the Energy Efficiency and Conservation Act last 16 September. Among the discussion items at the said event are the IRR's provisions on: the role of LGUs, energy management standards, responsibilities of the interagency energy efficiency and conservation committee, as well as fiscal and non-fiscal incentives for energy efficient projects. The DOE likewise received clarifications and comments on certain portions of the IRR from key health stakeholders.



### Senate Ways and Means Committee Hearing on CITIRA | 17 September 2019

ECCP attended the Senate Ways and Means Committee Hearing on Package 2 of the Comprehensive Tax Reform Program, the Corporate Income Tax and Incentives Rationalization Act (CITIRA), last 17 September 2019. At the hearing, Finance Undersecretary Karl Chua presented the DOF proposal; while Trade Undersecretary and Board of Investments Managing Head Ceferino Rofoldo talked about the DTI's position on CITIRA. Chairing the Committee Hearing was Senator Pia Cayetano, who was joined by Senators Juan Miguel Zubiri, Franklin Drilon, and Sherwin Gatchalian.



### JFC Meeting with Senator Imee Marcos 17 September 2019

The ECCP, together with members of the Joint Foreign Chambers, met with Senate Economic Affairs Committee Chair Senator Imee Marcos to discuss the proposed CITIRA Bill or House Bill No. 4157.

### Senate Hearing on Amendments to the Foreign Investment Act 23 September 2019

Last 23 September, the ECCP attended the Senate Hearing on the Foreign Investment Act amendments. The said measure is deemed to be crucial in attracting more Foreign Direct Investments in the Philippines. In the hearing, the Joint Foreign Chamber (JFC) advocated for the following: (1) reducing the required number of employees from 50 to 15 since, operationally speaking, a US\$100,000 enterprise cannot initially sustain a labor force of 50 persons; (2) removing practice of professions from the Foreign Investment Negative List (FINL) as it is not an investment activity; and (3) an annual review of the FINL instead of every two years as currently mandated.

### Senate Ways and Means Committee Hearing on CITIRA 24 September 2019

The ECCP was present at the 24 September Senate Ways and Means Committee Hearing on Corporate Income Tax and Incentives Rationalization (CITIRA) bills. At the said hearing, SWMC Chair Sen. Pia Cayetano heard from various government agencies, investment promotion agencies, business groups, and other relevant stakeholders their respective positions on the proposed tax reform package.

### Senate Hearing on Retail Trade Liberalization Act Amendments | 26 September 2019

The ECCP, together with colleagues from the Joint Foreign Chambers, served as resource speaker at the Senate Hearing on Retail Trade Liberalization Act. The ECCP recommends the amending of the Retail Trade Liberalization Act of 2000 to allow more foreign retailers to access the Philippine market by reducing the paid-up capital requirement from USD 2.5 million to USD 200,000. There has been a lengthy discussion among stakeholders on the threshold for minimum capital requirements. Nevertheless, the Chamber believes that the liberalization of the retail sector would have a positive spillover effect on the economy such as increasing foreign direct investments, creating more jobs, and increasing competition. Furthermore, this will help provide Filipino consumers with better choices and higher quality goods at lower prices and stimulate economic growth.







### Meeting with House Speaker Alan Peter Cayetano 30 September 2019

The ECCP, together with the Joint Foreign Chambers and the Philippine Business Groups, met with House Speaker Alan Peter Cayetano to discuss a number of legislative priorities such as the Amendments to the Public Services Act and Foreign Investments Act, as well as potential areas for cooperation.



### **PEZAInvestmentInsightsRoundTableDiscussion** 8 October 2019

The ECCP joined the Investments Insights Round Table Discussion hosted by Philippine Economic Zone Authority (PEZA) Director General Charito Plaza last 8 October 2019. This was attended by PEZA executives, PEZA-registered industries, government agencies, and resource persons including economists, investment experts and specialists to share their thoughts and suggestions concerning the Corporate Income Tax and Incentives Rationalization Act (CITIRA).



### **Agriculture Committee Meeting** 9 October 2019

The Agriculture Committee met to finalize the contents of its 2019 ECCP Agriculture Advocacy Paper which will be launched at the 2019 European-Philippine Business Summit. Additionally, the group were briefed on a recent ECCP meeting with the Bureau of Plant Industry on the government's initiatives on fall armyworm. Committee members also exchanged views on the effects of rice tariffication law to the local rice farmers as well as the African swine fever to the domestic hog industry. Lastly, they agreed to hold a field tour in Lipa City, Batangas in November.

### **Renewable Energy and Energy Efficiency** Committee Meeting | 9 October 2019

Energy stakeholders from the industry and European embassies in the Philippines gathered last 9 October for the ECCP Renewable Energy and Energy Efficiency Committee Meeting. The group received updates on the Implementing Rules and Regulations of the Energy Efficiency & Conservation Act from Philippine Energy Efficiency Alliance (PE2) President Mr. Alexander Ablaza. The committee members also exchanged their views on the increased promotion of renewable energy sources and microgrid systems, as well as relevant legislative priorities of the Philippine government.



### Human Capital Committee Meeting 15 October 2019

Members of the ECCP Human Capital Committee met last 15 October 2019 to review the final draft of the 2019 ECCP Human Capital Advocacy Paper. Attendees were also invited to the 2019 European-Philippine Business Summit on 24 October 2019 which will feature a session on the sector with the Committee Co-chair Atty. Eliseo Zuñiga, Jr. as one of the speakers. The group also discussed plans to set up learning sessions for 2020. Some of the initial topics include security of tenure, occupational safety and hazard, and the future of work, among others. Lastly, the ECCP will be conducting a needs assessment survey to identify the committee's priorities and objectives for next year.

### Automotive Committee Meeting 16 October 2019

The ECCP Automotive Committee invited Land Transportation Office (LTO) Assistant Secretary Edgar Galvante last 16 October to share with the committee members updates on the ongoing privatization efforts of the Motor Vehicle Inspection System as well as the latest developments on the Motor Vehicle User's Charge. Asec. Galvante also encouraged the committee to work closely with the government in their mutual advocacies to ensure the roadworthiness of vehicles and promote a culture of road safety among motorists, commuters, and pedestrians. Assistant Secretary Edgar Galvante was also accompanied by LTO Region 5 Regional Director Atty. The group identified key sector topics, including the promotion of sustainable tourism, along with the preservation of the Filipino culture and heritage, as well as improving safety in countryside and city tourism destinations. Also tackled were recent policies such as easement regulations in tourism areas and the service charge law. The committee looks forward to meeting with relevant government representatives to hear sector updates and talk about areas of cooperation. This committee meeting is supported by KMC Solutions, venue partner; and Bake & More, food partner.

### Joint Foreign Chambers' Meeting with Department of Trade and Industry Secretary Ramon Lopez 29 October 2019

The European Chamber of Commerce of the Philippines (ECCP), together with several local and foreign business groups, met with Department of Trade and Industry Secretary Ramon Lopez last 29 October 2019. A number of policy advocacies were raised including retail trade liberalization and PCAB licensing on fully foreign-owned contractors, among many others.

### Senate Technical Working Group on Retail Trade Act 7 November 2019

The ECCP attended the Senate Trade, Commerce, and Entrepreneurship Committee Technical Working Group (TWG) on Retail Trade Act Amendments - Senate Bill Nos.14 and 921. The TWG was also attended by representatives from the Securities and Exchange Commission, Board of Investments, Philippine Statistics Authority, and other foreign and local business organizations, among others.







### HoR Committee on Ecology Hearing on Regulation of Treatment / Waste-to-Energy Technologies | 13 November 2019

The European Chamber of Commerce of the Philippines (ECCP) was represented at the House of Representatives Committee on Ecology Hearing on bills on Regulation of Treatment / Waste-to-Energy (WTE) Technologies, namely: House Bill Nos. 4419, 933, 1938, and 618. Chaired by Rep. Glona Labadlabad and attended by representatives from the government including the Department of Environment and Natural Resources, Department of Finance and Climate Change Commission, as well as the industry and the academe, the hearing tackled key provisions under the proposed documents. Among the said provisions are the use of WTE technologies and their regulation, and incentivizing WTE-related activities.

### Joint Foreign Chambers' Meeting with the International Monetary Fund | 15 November 2019

Members of the Joint Foreign Chambers met with the International Monetary Fund to discuss the current business environment in the Philippines; FDI restrictions and potential reforms to make the country a more attractive investment destination; and updates on the tax reform.

The Joint Foreign Chambers Resource Committee met last 15 November to finalize its draft position paper on the House Bills proposing to establish a fiscal regime in the mining industry. Attendees also shared updates in the extractive industries as well as upcoming mining- and natural resources-related events. The group was also informed of an upcoming hearing of the House Ways and Means Committee on the said House Bills to which the group targets to submit its position paper.
